

MINUTES OF THE MEETING OF THE SCREENING COMMITTEE HELD IN THE CHAMBER OF THE SECRETARY, NDMC ON 01.04.2011 AT 11:30 AM FOR GRANT OF FIRST/SECOND/THIRD TIME BOUND PROMOTIONAL SCALE ON D.V.B. PATTERN.

The Committee was informed that NDMC had decided to grant three time bound promotional scales to NDMC Employees governed by S.S. Scale on DVB pattern on completion of 10/18/26 years of service respectively. These orders are effective from 01.04.1994.

The salient features of the Scheme are:

1. First time bound promotional scale shall be granted on completion of 10 years regular service be he a subordinate/ministerial staff member or a Group 'A' officer.
2. The second time bound promotional scale shall be given on completion of further 8 years of service i.e. 18 years of service in all from the date of induction of an official/officer at the base level on regular basis subject to the condition that in the case of Class-I officer, second time bound promotional scale shall be given to such of the officer who have been appointed on regular basis as per Recruitment Rules in their own right to the first promotional grade.
3. The third time bound promotional scale shall be given on completion of further 8 years service i.e. 26 years of service in all from the date of induction of an official/officer at the base level on regular basis. This benefit shall be given on acquiring the post upto second time bound promotional scale in their own right.
4. Time bound promotional scale to be allowed under the scheme shall be the next higher scale available as per the channel of promotion or in case where either a selection or trade test has been provided as condition precedent to promotion, then the next available scale shall be the time bound promotional scale of the category.
5. The benefit of time/bound promotional scale shall neither confer on the employee of the higher designation of the promotional post nor will it dilute the Service Rules of Recruitment/Promotion to such post according to his entitlement in due course.
6. Once an employee/officer enters into class-I service in his own right or in the time bound promotional scale, he shall be dealt at par with the direct recruit in the grade for the purpose of benefit of next promotional scales.
7. The above promotional scale of pay as mentioned above shall be given on the basis of seniority and requisite qualifying service which means that the period of Extra-ordinary leave for private affairs and dies-non period, in any, shall not be counted towards qualifying service subject to the following conditions:-

- i) Employees who are granted time bound promotional scale will continue to perform the same duties and functions and carry the same designation though their pay under these orders will be fixed under FR 22(1) (a) (i) till they are absorbed against regular vacancies in the line of their promotion and shall not be entitled to the benefit of any fixation of pay in the scale again.
8. The date of promotion to the post acquired after qualifying the trade test shall be the fresh induction in service for grant further time bound scale promotion.
9. As per decision of the Council the condition of acquiring promotion upto second time bound scale for grant of third time bound scale on completion of 26 years of service from the date of appointment has been waived off from 01.07.2006 on the pattern of Transco.

Establishment Branches have scrutinized the cases in accordance with the rules for grant of first/second/third time bound promotional scale as per details of the employees given in the statements.

The Screening Committee after considering the proposals, recommends for grant of first/second/third time bound promotional scale to the officials as under:
