3. They will be required to give one month's notice or deposit one month's contractual amount in the Council's treasury before leaving the service during the contractual agreement.
4. They will not be provided any residential accommodation.
5. They will be entitled for EL & HPL/Commuted leave as admissible to a Central Govt. servant governed by the Central Civil Services (Leave) Rules, 1972 during holding of contractual post.
