Their appointment is made subject to the following terms and conditions:-

1. Their services will be regularized in the regular pay scale on receiving of the police verification report.
2. The appointment is purely temporary and can be terminated at any time without assigning any notice or reason.
3. One month's notice or one month's wages in lieu thereof shall be required to be given to the Council before leaving the service during the period.
4. They will be on probation for two years.
