1. You require following documents for this service.
 - A Certificate signed by the Employer/Head of Office/Drawing and Disbursing Office stating total income of the parents in the previous financial year. This is to be submitted by the salaried class.
 - A certified copy of the Income Tax Return Form filed with the Income Tax Deptt. in support of income in the previous financial year from all other sources (including agriculture). In case no individual return was required to be filled by the parents, an affidavit on a non-judicial stamp paper of Rs. 2/- sworn before a class-I Magistrate stating details of total income from all sources in the previous financial year is to be submitted
 - An attested copy of the original birth certificate duly countersigned by Register Birth & Death (no affidavit will be accepted).
 - An attested copy of S/C or S/T certificate if applicable.
 - If the School last attended is one of the schools of N.D.M.C. attach a certificate duly stamped to the effect from the Headmaster/Head Mistress concerned.
