MINUTES OF THE FIRST MEETING OF HIGH EMPOWERED COMMITTEE HELD IN THE COUNCIL ROOM, PALIKA KENDRA, NEW DELHI ON 21.04.2017 AT 10.30 AM FOLLOWED BY SECOND MEETING HELD ON 24.04.2017 AT 9:00 AM IN THE COUNCIL ROOM REGARDING HEALTH LICENSES

With the approval of the Chairperson, NDMC, a High Empowered Committee was constituted vide O.O. No. 157/D/PS/CP/17 dated 13.04.2017 for Grant or Renewal or Suspension or Cancellation of Health Licenses in NDMC area and stoppage of use of premises in contravention of licenses in accordance with the provisions of Section 331(1), 331(2) and 333 of NDMC Act, 1994 with immediate effect. Accordingly, a meeting was held on 21.04.2017 at 10.30 PM in the Council Room, Palika Kendra and a subsequent meeting was held on 24.04.2017 at 9.00 AM which were attended by the following members:-

1. The MOH shall process all the cases approved by the High Empowered Committee for the formal approval of the Secretary, NDMC.
2. The committee deliberated that many sanction plans are not available with NDMC and it may take some time for the applicant to trace the same in the L&DO office. Therefore, it is proposed to give six months time to the applicant for submission of sanction plan and Submission of NOC from L&DO for conversion of land use. MOH to keep record of such cases and place before the

committee such cases immediately after expiry of 6 months for reconsideration/revalidation subject to submission of requisite document and inspection reports..

3. Some unauthorised construction were reported in already running restaurants which came up for renewal (other than the cases where notices u/s 247, 248 and 250 of NDMC Act are issued and violation still exist). The committee deliberated and approved such cases subject to removal of such unauthorised constructions. Time period of six months is allowed for this action. Such cases will be placed before the committee for revalidation alongwith inspection reports of EBR department and subject to submission of required records.
4. Structural safety certificate, undertakings for usage of mezzanine floor and NOC from Delhi Fire Service (wherever mentioned) are required to be submitted before renewal/Grant.
5. MOH shall furnish the copy of documents submitted by the applicant post approval (in cases where such conditions are imposed), to the Departments concerned for their records.
6. It shall be mentioned in the approval , so communicated to the applicant that the grant/renewal of health license does not ipso-facto regularise and/or prohibit NDMC from taking action against any violation of the provisions contained in the NDMC Act/Rules including those relating to unauthorised construction/encroachment/misuse.
7. The MOH shall ensure that the license/renewal certificate shall only be issued after the applicant submits the requisite documents/remove breaches mentioned against the approvals recommended by the High Empowered Committee.
8. Since Delhi Fire Service has still not notified its policy of classifying Assembly of persons permissible in a building by the seating capacity thereof, an undertaking from the applicant may be obtained for submission of their NOC till finalisation of the policy of

DFS. The seating capacity in the restaurants shall be restricted, at all times, as per minutes of the meeting held on 08.12.2016.
