The Council deliberated in detail the report of the Consultants recommending various options for redevelopment of Chanakya Cinema Complex. The Council took note of the suggestion in the report that there is substantial demand for a multiplex as well as a commercial complex which can be a shopping complex or an office Complex and projection of substantial increase in the revenues to NDMC from such a redevelopment of the Complex as compared to the present revenues from the single screen cinema.

2, <u>Name of the Deptt.</u>: Civil Engineering, Public Health Circle, Water Supply Division.

3. Brief History of the Subject

Director (Hort.) vide letter No. D-118/PA/DH/06 dt. 21.04.06 has intimated regarding horticulture improvement of the following roads and requested to provide tubewells with hydrants system for irrigation:-

i) Prithavi Raj Road, (ii) Janpath Road, (iii) Aurangzeb Road, (iv) Akbar Road, (v) Tughlak Road, (vi) Safdarjung Road, (Vii) Moti Lal Nehru Marg, (viii) Man Singh Road, (ix) K.Kamraj Marg, (x) Maulana Azad Road, (xi) Dalhousie Road, (xii) Church Road, (xiii) Sunehari Bagh Road.

Accordingly, this case was referred to CGWA. CGWA has accorded no objection for construction/development of tubewells on these roads vide letter No. 26-9/TS/CGWA/200(PY)-24 dt. 13.07.06.

4. Detailed Proposal of the subject

As per para 2 of the standing order No. 07/2003-04, a sub committee was nominated by Chairperson comprising of the following officer –

- 1. Sh. Subhash Chandra, Director (Hort.)
- 2. Er. R.S. Thakur, SE(PH)
- 3. Er. N.N. Sharma, SE(Construction)
- 4. Er. A.K. Pathak, EE(Planning)
- 5. Er. C.M. Narang, EE(W/S)

All the members of the Sub Committee are of the opinion that there is no other alternative except to provide tubewells on these 13 roads alongwith hydrant system for irrigation purposes.

It has, therefore, been proposed that 26 Nos. tubewells are to be installed i.e. one each on the either side of the above mentioned 13 roads.

Provision for drilling of 120 mtrs. deep tubewells with 200mm dia M.S. Plain/Slotted pipe upto 90 Mt. depth and thereafter 150 mm dia M.S. Plain/Slotted pipe upto 120 Metre depth including supplying and installation of 5 HP submersible pumpset alongwith all electrical an d mechanical fixtures, chambers and providing and laying 50mm dia G.I. pipe with hydrants have been taken. The depth of the tubewells have been taken as 120 Mt. due to decreasing under ground water level. The average discharge of tubewell is generally about 10,000 litres per hour which is not sufficient enough to feed both sides of the roads and hence the separate tubewell has been proposed on either side of each Road.

5. Financial implications of the proposed subject

Accordingly, a proposal was framed amounting to Rs. 2,27,06,200/- by the department and the same was got checked from the main planning. The scheme has been included in the budget and the provision of Rs. 150 Lacs has been made in budget estimate for the year 2007-08 under code head F-11 vide item No. 236 (22).

7 Comments of the Finance Department on the Subject

The observation of the Finance Department dt. 2.11.06 and 5.12.06 were clarified and finally, the Finance has observed as under :-

"It has been noticed that under Tenth Five Year Plan, there is a scheme titled as "Environmental Improvement along drains, roads and nallahs under the Head H.1.8 A(page 66 of current year's Budget Book) 2006-07 is the last year of the Tenth Five Year Plan. The scheme in question is to be implemented, if cleared, in Ist and 2nd year of the said scheme, as provision of water for Horticulture purposes will definitely improve the environment. The department may as such is advised to include the said scheme under Eleventh Five Year Plan. There is no bar of taking up any scheme meant for Horticulture purposes under Plan. Subject to the said advice, we concur in the PE amounting to Rs. 2,27, 06,200/- (Rupees two crore twenty seven lakh six thousand two hundred only) as checked by the Planning subject to the conditions given by CGWA in their clearance letter dt. 13.07.06 are complied properly and time schedule as proposed is adhered to.

For budget provision, the scheme has been included in the budget estimate for the year 2007-08 under code head F-11 vide item No.236 (22). It is also confirmed that CGWA recommendation will be considered during the detail planning of the project.

 Name of Subject/Project & Sub Head S/R of roads in NDMC area during 2006-07. Providing and laying cc grass pavers in Kaka Nagar Colony, New Delhi.

2. Name of Department.

CIVIL ENGINEERING DEPARTMENT ROAD-I DIVISION.

3. History of the Subject/Project :

In Kaka Nagar colony, there is no footpath/pathway along the service roads and the residents have to walk on the carriage way of service roads. It has been proposed to provide interlocking grass pavers conforming to IRC specifications along the service roads flush with road level. The scheme is prepared on the pattern of interlocking pavers provided along service roads of Bapa Nagar. Administrative approval and expenditure sanction for Rs.80,55,200/- (Rs. eighty lacs fifty five thousand two hundred only) was accorded by the council vide item No.7(A-4) dated 19.04.06.

This case is regarding acceptance of the contract. This is first call of tender. M/s Jai Bharat Construction is the lowest tenderer with quoted rates @ 6.00% below the estimated cost of Rs.63,13,518/- (Rs. sixty three lacs thirteen thousand five hundred eighteen only) and tender amount works out to Rs.59,34,309/-(Rs. fifty nine lacs thirty four thousand three hundred nine only). The case is placed before the council for acceptance of the tender.

4. Detailed Proposal on the Subject/Project

60mm thick precast factory made Cement Concrete Grass Pavers shall be provided along the Kaka Nagar service roads, after laying the base course of Water Bound Macadam (WBM) as per IRC specifications. Provision of cross drainage work has also been taken, wherever required, to facilitate drainage of water.

5. Financial Implication of the Proposed Project/Subject

The tender amount of M/s Jai Bharat Construction works out to Rs.59,34,309/-(Rs. fifty nine lacs thirty four thousand three hundred nine only). The necessary funds are available to meet the expenditure of the work during current year budget provision of Rs.1500 lacs item No.239 page 110 under the head of G.1.3 (V)- "S/R of roads in NDMC area". The Council also accorded ex post facto approval of the action taken to award the work to M/s Jai Bharat Construction.

- I. Name of the Project:- Providing 66KV Feeders (4X630Sq.mm single core for each S/S) from S/S Park Street to S/S School Lane & S/S Vidyut Bhawan
- 2. Name of the Department Concerned:- Electricity Department

3. Brief history of the project:- At present installed transformer capacity of S/S School Lane & S/S Vidyut Bhawan is 140MVA at each S/Stn. The present feed to each of these sub-station is from G.T. Station of DTL. The feeder capacity at each of these sub-stations. Through double circuit 630 sqmm. S/C Aluminium conductor XLPE cable is about 90 MVA. Thus NDMC is not able to utilize the full transformer capacity at any of these two sub-stations. Moreover in case of any fault or breakdown at G.T. Station or in the cable from G.T. Station, the supply cannot be restored from any alternate source. The matter was taken up in the Steering Committee Meeting as well as in DERC and after a lot of persuasion DTL has agreed to provide two bays as alternate source of supply from S/S Park Street. With the above proposed arrangement, NDMC will not only be able to utilize full transformer capacity at each of these sub-stations but will also be able to get alternate source of supply at each of these two sub-stations.

4. Detailed proposal on the Project: - Originally, 66KV Feeder of size 3x630sqmm. Single core XLPE insulated Aluminum conductor cable was proposed to be laid from S/S Park Street to S/S School Lane & S/S Vidyut Bhawan. The estimate amounting to Rs. 13.17 crore for the same was approved by the Council vide Reso. No. 9(B-16) dt. 13.2.2006. The scheme was reviewed by the CEA and vide its letter No.DPD/UT/312(NDMC)/2005/43 dated 29.3.06 had suggested that 4 lengths of 66KV XLPE single core cable from Park Street to School Lane and Park Street to Vidyut Bhawan might be laid in place of 3 lengths for meeting any contingencies in future. Subsequently, the meeting taken by Member (GO&D), CEA on 26.5.06, (minutes circulated vide letter No. DPD/UT/315(Delhi)/2006/97 dated 5.6.06) it was decided that the estimate may be revised for laying 4 lengths of 66KV cable.

Further in this regard E-in-C, NDMC has also taken the meeting on 16.10.06 with Director (UT) CEA and it was decided that the 4th cable may be laid and the works may be started. Meanwhile, the estimate may be revised for taking approval of the competent authority for administrative approval and expenditure sanction. The work has been taken in hand. CEA has been approached to provide consultancy for the work. DTL is being vigorously followed up to make available two new bays for NDMC at 220KV S/S Park Street.

Accordingly the estimate has been revised amounting to Rs.17.39 Crores including 3% contingencies to cover the cost of the above work.

The expenditure shall be chargeable to the original works under the head of A/c E-4-1 for which a budget provision of Rs.13 Crores has been kept during the year 2007-08

5. Financial implications of the proposed project:-

The revised estimated cost for laying of 66KV feeders from S/S Park Street to S/S School Lane & S/S Vidyut Bhawan is Rs.17.39 Crores. The expenditure shall be chargeable to the original works under the head of A/c E-4-1 for which a budget provision of Rs.13 Crores has been kept during the year 2007-08

- (c) Tenders were invited on 11.12.06. The rates quoted by lowest tenderer were found abnormally high. Accordingly the tender was rejected and re-invited on 12.01.07 M/s R.K. Sharma & Co. is the lowest tenderer & the negotiated amount is Rs. 68,60,317/- which is 89.43% above the estimated cost.
- **4.** Detailed proposal on the subject / project : 40 mm thick red/white sand stone flooring and kerb stone of red sand stone will be provided.
