3. Brief History:

Talkatora Indoor Stadium and Shivaji Stadium has been selected for competition venue (Boxing) and Practice Venue (Hockey) respectively for Commonwealth Games 2010. The Joint Commissioner of Police, Commonwealth Games Planning Delhi vide their letter no. 138/Joint CP/CWGP dtd. 26.02.08 intimated for optimization of security arrangement through CCTV monitoring, following areas have been identified to be covered.

- 1. Pedestrian and Vehicle approach to the Venue
- 2. Access control/screening areas.
- 3. Droop off and pick up points/load zones in close vicinity of the venue
- 4. Parking areas of T-1 and T-2 athletes parking and VVIP areas
- 5. Spectators plaza, stands and corridors
- 6. Areas of athlete movement and Fields of Play
- 7. VVIP Lounge, VVIP seating areas
- 8. Other areas of importance
- 9. Along outer perimeter.

It was further suggested by the Joint Commissioner of Police, CWG to interact with M/S ECIL who had already carried out the study regarding "Integrated Security Project" for Delhi Government Secretariat, Delhi and have undertaken the installation of security equipments and CCTV system for Parliament House and has proposed that study of all the Competition and Training Venues may be assigned to ECIL. In this regard, a letter was sent to M/S ECIL to submit their offer considering all the above parameters.

4. Detailed proposal on the subject/project:

M/S ECIL submitted a report on Supply, Installation, Testing & Commissioning of Security Systems at Talkatora & Shivaji Stadiums which includes Price Estimation for Talkatora Stadium and Shivaji Stadium alongwith the terms and conditions with the following broad details of cost involved:

A copy of the report submitted by M/S ECIL was sent to Joint Commissioner of Police, CWG Planning for their comments with a copy to Joint Commissioner of Police, New Delhi also.

There has been number of meetings on this issue at all levels to resolve the issue particularly on the following points.

- 1. Whether Delhi Police will undertake the responsibility of installation of CCTVs through ECIL in all the venues
- 2. Whether the venue owners have to call for the open tender where ECIL also may be asked to bid
- 3. Whether the Turn Key project of design, installation and operations of CCTVs can be entrusted to ECIL directly.

In one of the meeting held with the Union Home Secretary on 3.11.08, it was decided that ECIL in consultation with Delhi Police will be the only one agency to conduct survey of CCTVs at all CWG Venues and will also installed the same and Venue Owners would bear the cost for the same.

Hon'ble Lt. Governor, Delhi also conveyed a meeting to discuss security and traffic relating infrastructure issues for CWG 2010 on 24.02.08 as per the note of Pr. Secretary to LG vide U.O. no. 5(11)/RN/2009/RM/3006 dtd. 18.02.09, (**Annexure-I**) (pages 20 – 33) and a copy of the minutes of Apex Committee meeting was circulated by OSD to Lt. 7. Comments of the Finance Deptt. on the subject:

Considering the recommendations/instructions of the various authorities like Police, MHA, O/O L.G. as detailed in the preamble of the draft agendum, there appears to be no option but to place the matter before the Council seeking decision, placing on record detailed justification/circumstances leading to selection of consultancy services by nomination, in terms of provisions of Rule 176 of GFR.

With reference to the discussions held on 04.02.2009 regarding various pending infrastructure issues relating to Commonwealth Games 2010, it is submitted that a number of security and traffic related issues are still pending with various venue owners, Organizing Committee, Sports Ministry and Home Ministry, etc. which require urgent attention. These issues are of utmost importance in proper conduct of the Commonwealth Games 2010 and, therefore, require to be tackled on war footing level from now onwards. A brief note on these issues is included herewith for kind perusal of Hon'ble LG as Annexure "A".

There are also some infrastructure related issues some of which were also discussed in the meeting taken by LG, Delhi on 04.02.2009. However, we feel that these have not been satisfactorily resolved and some solutions to these problems need to be found. These have been mentioned as Annexure "B". If considered appropriate, these issues could also be discussed.

Hon'ble LG, Delhi, in his meeting dated 04.02.2009, has also desired to hold a separate meeting on these issues. Therefore, on behalf of CP, Delhi may I kindly request you to convene a meeting of following representatives of concerned agencies in LG House so that these pending issues can be solved :

Security & Traffic related Infrastructural Issues for CWG-2010

- In the meeting of Union Home Secretary on 3.11.2008 it has been decided that ECIL in consultation with Delhi Police will be the only one agency to conduct survey for installation of CCTV at all the CG-2010 venues and will also install the same and venue owners would bear the cost for the same. However, no plan has been sent by any venue owning agency to ECIL with a letter authorizing them to take necessary action. Further, venue owners are wrongly interperating the directions of Union Home Secretary that instead of venue owners, Delhi Police would approach ECIL for this purpose. Delhi Police has already constituted a committee to examine all such reports to be received from ECIL for comments on law & order, security & traffic point of view. A copy of the minutes of the meeting taken by the Union Home Secretary on 03.11.2008 is enclosed as annexure.
- In respect the above issue DDA has sought clarification on the following points:-
- 1. Whether Delhi Police will undertake the responsibility of installation of CCTVs through ECIL in all the venues;
- 2. Whether the venue owners have to call for the open tender where ECIL also may be asked to bid;
- 3. Whether the Turn Key project of design, installation and operations of CCTVs can be entrusted to ECIL directly.
- To monitor the videos/pictures projected by CCTVs installed at various venues & Games Village a centralized control rooms have to be constructed at a each venue & games village. In addition a fead would be needed for the central police control room away from the venues. A decision has to be taken as to who will build these venue control rooms.
- A decision has to be taken with regard to help line services in Delhi and neighbouring states during games period.

mischief monger and to follow such persons. This has been mentioned in the Security Vetting Reports, already sent to venue owners and other concerned agencies.

- No decision has been taken regarding provisions of overlays such as water-proof tents, folding tables, moulded chairs, office table & chairs, Barricades for queue management, plastic containers, plastic trays, drums, ropes, channelizers, photo capturing machines, bar code readers & lockable cabinets etc.
- Decision regarding security arrangements and agencies responsible for Queens Baton Relay are yet not finalized.
- Accreditation policy has yet not been finalised/intimated, by OCCG so far.
- Roles and responsibilities/chain of command of all the agencies at various venues (SOP) has yet not been specified, by OCCG in reference to that of venue commander & venue security commander.
- Issue regarding recruitment of volunteers needs immediate attention as the time is running out of hand for their training by various agencies.
- A high level committee has been constituted by Delhi Police to study the plans of all the competition/training venues & games village and the recommendations of the committee have been communicated to all concerned as Security Vetting Reports (SVR). Since then six months have elapsed, however the response is not forthcoming.
- Security Instructions of MHA for under construction venues have been circulated to all the venue owners. However, the same are either being not followed or partially followed as venue owners are expressing their inability to do so. Under such circumstances, any untoward incidence can take place despite regular A.S.Check by Delhi Police. Strict directions in this regard needs to be issued at this stage itself to venue owners.
- Photo ID Cards for the workforce requires to be issued. These ID Cards should have biometric security features, but even this instruction is being followed partially only.

- Provision for emergency management centre at each venue which shall have representatives from Delhi Fire Service, NSG, & Health Services, etc. to plan and execute venue emergency responses, are required to be established from now onward itself.
- The number of VVIP, VIP, T1 & T2 category vehicles have to be strictly in accordance with the space available with the venue owners at each venue; a decision in this regard needs to be taken.
- The sanction for the security equipments demanded from MHA is still awaited.
- No major Conference/ITPO fair or VIP visits except related to Commonwealth Games to be committed by the Govt. for ensuring that full police force is available for CG-2010.
- The security of the Airport is presently with CISF. However, during CG-2010, Delhi Police will be looking after the security of players/officials/VIPs from the airport itself. As such a separate control room of Delhi Police will be required at IGI Airport alongwith sufficient barracks and secured parking facility for pilot/escorts & vehicles. It shall also have a separate armory for weapons etc.
- Issue regarding using/developing the parking space and spectators holding zone in nearby schools, colleges, DTC Terminals and parks etc. has yet not been resolved.
- For decongesting the city roads and availability of maximum police force during CG-2010, following measures are requested to be taken:-
 - Adjustment of holidays of courts, colleges, schools; closure of all markets on Thursday i.e. 14th October, 2010 (closing ceremony)
 - On Sunday i.e. 3rd October, 2010 (Opening ceremony);
 - Swapping holidays on Saturday 16th October, 2010 with Thursday, 14th October, 2010 as government holiday of government servants.
 - Requesting all private and public sector companies to do likewise.
 - Issuing of notification for bank holiday on 14th October, 2010.

Apart from above various venue specific issues are as under :-

Commonwealth Games Village:-

- > Space for Police Command & Control Centre at transport mall within operational area.
- Provision for a double flyover at NH-24.
- > Parking space for 300 buses in a nearby secure location is yet to be finalised.

Jawahar Lai Nehru Stadium:-

- > Traffic circulation & parking for athletes buses & spectators on southern side of stadium still not finalized. Need for conflict free movement and minimum parking space required for 300 buses is yet to be finalised.
- > As a separate games dedicated lane has been committed, a slip road on the proposed elevated Barapullah Nalah road on Lala Lajpat Rai Marg is required as the exit point for many other venues like Talkatora Indoor Stadium, Dr. S.P.M. Swimming & Aquatic Complex, M.D.C.National Stadium, Sirifort & Karni Singh Shooting Range, other wise Bhairon Marg will be the only option left.
- > Making Metro a compulsory mode of conveyance, instead of private vehicles or charted buses, for most of the officials working in CGO Complex & nearby office has still not been communicated to Delhi Police.
- FOB on B.P.Marg near NBCC Building from M.C.Khann Mkt, side.
- \gg Issue of parking for 500 vehicles of VIPs in addition to T₁ & T₂ vehicles has not been resolved as yet, especially for opening/closing
 - ceremony.

M.D.C.National Stadium:-

- Multiple gates on the perimeter wall towards Mathura Road side for easy entry/exit of spectators.
- Increase of holding area.

- The proposed pick-up/drop-off point on Mathura Road side has a 'Mazar'. It's shifting might become a matter of concern.
- Solution regarding the issue of conflicting traffic movement at Bhairon Marg-Mathura Road Junction & Bhairon Marg-Ring Road Junction as there is heavy traffic on these roads/junctions.
- Sub-ways at 'C' Hexagon.
- Widening of footpaths on Easten side of Mathura Road towards Zoo & near Pragati Maidan Metro Station alongwith provisions of FOB to cross over Mathura Road to reach the Stadium.
- Improvement of 'T' junction on Mathura Road with Subramaniam Bharti Marg to accommodate increased traffic towards zoo parking and to cater flow of pedestrian is needed.
- Need to address traffic chaos caused by exiting traffic at Sunder Nagar traffic signal.
- Augmenting the Capacity of footpath at Bhairon Marg from Sub-Way upto Bhairon Marg Junction with Mathura Road to accommodate the pedestrian flow.

Apart from above various traffic/transport related issues regarding MDC National Stadium have been resolved under the UTTIPEC (Unified Traffic & Transportation Infrastructure Planning & Engineering Centre) a copy of the same is also enclosed herewith. It is requested that the recommendations of UTTIPEC may also be implemented in toto.

R.K.Khanna Sports Comlex:-

- Providing clear access for spectators from Harsukh Marg & Africa Avenue to reach the venue through Dear Park, the designated entry point for spectators.
- Additional parking for VVIP vehicles.
- Developing of T₁ & T₂ categories alongwith Africa Avenue beyond road leading to Deer Park.

Dr.S.P.M.Swimming & Aquatic Complex & Talkatora Indoor Stadium:-

Engineering solution to decongest RML Round-about.

- Developing of Talkatora Garden as the spectators holding and movement area for Talkatora Indoor Stadium and Dr. S. P. M. Swimming & Aquatic Complex.
- FOB is required on Park Street for movement of pedestrians.
- Widening of Motor Teresa Road and Sardar Patel Marg.

Apart from above various traffic/transport related issues regarding Dr.S.P.M.Swimming & Aquatic Complex & Talkatora Indoor Stadium have been resolved under the UTTIPEC (Unified Traffic & Transportation Infrastructure Planning & Engineering Centre) a copy of the same is also enclosed herewith. It is requested that the recommendations of UTTIPEC may also be implemented in toto.

Thyagraj Sports Complex:-

- Development and widening of roads around Thyagraj Stadium.
- The entrance / exit gates need to be wide enough to cater to the demand of traffic flow of VIP / athletes vehicles.

Delhi University:-

- The perimeter wall shall be 2.8 mtr. high solid wall mounted with 1.5 mtr. high wrought iron bars with "Y" shape on top instead of a simple 2 mtr. high wall proposed in the plan.
- For 'park & walk', Metro parking would be required during game days.
- A proper ramp for entry / exit for games family, near Meghdoot
 Hostel is needed (elevation difference of 2 mtrs.)
- Developing/improvement of Ridge Road network to be.
- Creation of additional parking space for VIPs.

Dr.Karni Singh Shooting Range:-

- Widening of the road leading to Dr. K. S. S. range from M. B. Road to four lanes with proper illumination as this is a single carriage road with sharp bends.
- Redevelopment of Anandmai Marg as games exclusive lane for athletes from Games Village and other venues is proposed through

Anandmai Marg instead of Mathura Road which is already congested.

Siri Fort Sports Complex:-

- Stay has been granted by Hon'ble Supreme Court of India on the issue of cutting trees and construction of road in Sirifort Sports Complex. No fresh plan after their duly vetting by Supreme Court Monitoring Committee has been submitted by DDA to proceed further.
- In the previous layout plans there was a provision for two FOBs towards Siri Fort Road. However, now there would be only one FOB. As this FOB would serve the entry / exit point for spectators / operational staff the width of the FOB must be sufficient and separated for one another.
- Providing of signal free right turn connectivity from J. B. Tito Marg to Siri Fort Road for smooth flow of traffic, it has Substantial legacy value as well.
- Widening of the road leading to Siri Fort Complex from August Kranti Marg and re-designing of the intersection to allow free left turn.

I.G.Sports Complex:-

Providing Bus parking bays in front of Power House for focal point and park and ride buses (earlier a DTC Terminal).

Apart from above various traffic/transport related issues regarding I.G.Sports Complex have been resolved under the UTTIPEC (Unified Traffic & Transportation Infrastructure Planning & Engineering Centre) a copy of the same is also enclosed herewith. It is requested that the recommendations of UTTIPEC may also be implemented in toto.

MINUTES OF THE MEETING HELD UNDER THE CHAIRMANSHIP OF SHRI MADHUKAR GUPTA, UNION HOME SECRETARY ON 03.11.2008 AT 1500 HRS TO REVIEW THE SECURITY ARRANGEMENTS FOR COMMONWEALTH GAMES-2010, DELHI

List of Participants is attached.

Initiating the discussion, Home secretary desired to know the current status of security arrangements at Construction sites for competition and training venues and 2. other security related issues for Commonwealth Games- 2010, Delhi.

Secretary (Sports) stated that the security arrangements at the competition/training venues are being reviewed/ discussed by him with Director of Intelligence Bureau, Sports Authority of India, Organising Committee and venue 3. owners. There are certain security related issues pertaining to access control at construction sites, which need to be resolved. The issue of installation of CCTV by venue owners also needs to be resolved as early as possible. He also suggested that the process of security vetting of venue plans or traffic plans by Delhi Police needs to

be further streamlined. Principal Advisor, Organising Committee of the Commonwealth Games requested that Delhi Police/ CPMF may be deployed for security at construction site. With regard to installation of CCTVs, Venue owners have approached ECIL based on 4. the suggestion from Delhi Police but they have refused to act as consultant. He also suggested that Delhi Police may indicate number/ location and specification of CCTVs for each venue and thereafter venue owners may be asked to install with their own fund through any agency.

Home Secretary emphasised the need to ensure proper security at the construction sites and reiterated that the guidelines issued by MHA for access 5.

control should be strictly enforced. With regard to the enforcement of guidelines on "Access Control of Materials", strict perimeter access control, surveillance and complete security vetting of all workers would to a certain extent ensure compliance. He said that deployment of CPMFs or Delhi Police cannot be the solution to this He suggested that a system of checking should be put in place whereby a Security Liaison (SL) Team, comprising representatives of IB, NSG, Delhi Police, Venue issue. owners, Organising Committee and Ministry of Sports, should visit all the construction sites periodically, and also have anti sabotage checking done with help of the required equipments such as Deep Search Mine Detectors, bomb detection/ disposal equipments/squads etc. A detailed SOP may be developed by Delhi Police to ensure that this drill is done in organised manner. Apart from the periodical check / the SL Team, the general security guidelines of IB should be strictly followed with the help of private security agencies.

6. HS further recalled that the issue of provision of CCTVs and other security requirements at the venue sites/buildings such as identification of spaces for control rooms, conduits and ducting for CCTV cabling etc., and other elements like watch towers, security cabins, etc has been discussed in detail earlier and it had been decided that all these elements should be built in at the time of security vetting of the Plans. Even the elements which can be provided in the form of overlays to the building designs and plans should also have been looked into at the time of security vetting of plans. Therefore, HS requested Secretary (Sports) to review the security plans venue-wise to ensure that all the elements of security are provided for in the above background.

7. On the issue of entrusting the job of design and installation of CCTV at all venues to ECIL, HS suggested that Delhi Police should include these venues also in their master plan for installation of CCTVs in important market places/ other sites in Delhi, and work out an arrangement with ECIL for this purpose. With regard to the cost, HS said that this would have to be borne by venue owners. At the same time, the Organizing Committee may also explore the possibility of sponsorship and permit the owners to retain CCTVs as legacy. HS mentioned that during the Games Delhi Police would have to be responsible for operating the entire system of surveillance. Therefore, Delhi Police should earmark a few personnel for this purpose and get them trained intensively.

8. HS stated that Delhi Police would be responsible for security arrangements relating to Commonwealth Games- 2010. Therefore, Delhi Police should start working on detailed security plan under their operational control. It was also decided that the report of IB on the security arrangements made for the Beijing Olympics would be sent to Delhi Police for study and necessary action at their end.

9. On the issue of permitting Cellphones, Bags etc. inside the venue on opening and closing ceremony days, it was felt that a final decision can be taken at a later stage depending on preparedness on security arrangements.

10. HS stated that there would be another review meeting after two months. In the mean time, Secretary (Sports) would have reviewed security related issues at each venue.

The meeting ended with thanks to the chair.

Hon'ble Lt. Governor warmly welcomed all the participants to the meeting. While noting that as per Union Home Secretary's Meeting Minutes of 30.11.2008, the overall responsibility of the security for the Commonwealth Games 2010 would be that of Delhi Police, he observed that a number of coordinated measures would require to be taken by the various stakeholders to ensure safe and secure Games in October 2010. 3. <u>Brief History of the Subject</u>

Presently, there exist 66 Nos. tubewells in working condition in NDMC area and 26nos more tubewells are being developed for use of Horticulture Department. However, no such tubewell exists for irrigation of Shanti Path Lawns measuring around 30 acres. Unfiltered Water Supply provided by CPWD is not adequate and besides that, it is erratic also, on account of which, it has not been possible for the Horticulture Department to maintain the lawns properly. It is, as such, desired by Horticulture Department to develop 6 Nos. tubewells for Shanti Path Lawns. Further more, the existing open well at Satya Marg which feeded Nehru Park for irrigation activities has dried up thus creating shortfall for proper maintenance of Nehru Park also. The possibility of reviving the Satya Marg open well has been explored but it has not been possible to do the same. As such, 2 tubewells in the vicinity of Nehru Park are also proposed to be developed, thus making total No. of tubewells as 8 Nos.

4. <u>Detailed Proposal of the Subject</u> :

It is proposed to develop 8 No. tubewells for proper upkeep of Shanti Path Lawns and Nehru Park (6 No. for Shanti Path Lawns and 2 Nos. for Nehru Park). The development of tubewell is proposed to be carried out through DTH method by drilling 250mm dia bore up to 90mm depth and 200mm dia further upto 30 mtr. depth. The pipe assembly consists of 200mm dia ERW M.S. Housing and Slotted up to 90 mtr. depth and 150mm dia ERW M.S. Slotted and blind pipe upto 30mm depth packed with gravel all round. Each tubewell is proposed to be developed with Air Compressor. Provision of 3/5 H.P, Sleek, high head submersible pumps with necessary electrical and mechanical fixture and laying of 40 to 50 mm dia GI distribution network has been made for carrying out water from tubewell to the point of requirement.

5. <u>Final Implications of the Proposed Subject :</u>

The project cost for development of 8 Nos. tubewells, providing electrical and mechanical accessories and distribution network is Rs. 66,68,800/- approximately.

6. <u>Implementation Schedule with Timeliness for each stage including Internal</u> <u>Processing :</u>

The project is phased to be completed in a period of one year after award of work.

7. <u>Comments of the Finance Department on the Subject :</u>

The Finance Department has observed as under:-

" In view of what has been brought on record, if approved, we may concur in the estimate amounting to Rs. 66,68,800/- (Rs. Sixty six lacs sixty eight thousand eight

hundred only) as checked by Planning and recommended by ACE (C) subject to correctness of information and availability of funds for execution of work. This issues with the approval of FA."

8. <u>Comments of the Department on Comments of Finance Department :</u>

As regards the comments of Finance Department, it is submitted that the information with regard to above said work, as provided by the Department, is correct. Regarding availability of funds, a provision of Rs. 50 lacs exists in the budget for the year 2009-10. Vide item no. 354.11. Necessary action with regard to revision of the same, as per requirement, will be taken while putting up revised budget proposal for the same year.


