1. Name of the subject/project

Sub: Improvement & upgradation of colony roads, back lanes taken over from CPWD in Sector-I & III DIZ Area, Gole Market

2. Name of the Department

Civil Engineering Department, Road Division-V

3. Brief history of the subject/project

- (a) The roads, lanes/ back lanes were taken over from CPWD in Sector-I & III DIZ Area, Gole Market in Dec.'07.
- (b) The roads & back lanes in these colonies taken over from CPWD are in a dilapidated condition and need immediate repairs/ upgradation. Accordingly a comprehensive plan for upgradation of these colony roads to concrete roads alongwith improvement of civil works of parks was prepared and approved by Council through various resolutions.
- (c) Since the condition of these roads, lane/ bylanes is extremely bad & residents are suffering badly so Administrative Approval and Expenditure Sanction for providing concrete roads, lane/ bylanes taken over from CPWD in Sector-I & III DIZ Area, Gole Market for Rs.6,61,66,600/- was approved by the Council vide Resolution No. 03(A-136) dated 15 Jan.'10 alongwith following directions:-
 - (i) Taking over of the colony roads/ lanes/ service roads & parks from CPWD in Sector-I & III DIZ Area, Gole Market Area of NDMC for its maintenance, upgradation/ improvement etc. in anticipation of formal communication to be received from CPWD for transfer of the public street & parks, maintained by CPWD to NDMC.
 - (ii) To carry out the maintenance, upgradation/ improvement works in the area, taken over from CPWD, out of NDMC funds, in anticipation of receipt of direction, from the Central Government regarding vesting of these roads/ street & parks in favour of NDMC.

- (d) The case was also discussed in Special Council meeting on 03 Sep.'09. It was resolved by the Council that work may be taken up by NDMC itself out of its own funds & necessary provisions to be made in Budget 2010-11 & Revised Estimate 2009-10.
- (e) The request for sending formal communication to NDMC for transfer of public streets maintained by them was sent to Director General (Works), CPWD on 15 Sep.'09.
- (f) The office of Director General (Works), CPWD vide letter No.7/17/07-W.II/DGW dated 01 Jan.'10 (Annexure 'A' See pages 32 33) has intimated that it is not advisable to vest the streets & parks with NDMC as these colonies are to be redeveloped as per the provisions of new master plan norms which may necessitate a complete realignment of roads & change in layout plan.
- (g) Accordingly the case has been taken up with Secy (UD) vide Chairman Office D.O. letter no. 290/PS/C'Man/CE(R)/10 dated 21 Jan.'10 (Annexure 'B' See page 34) for issue of directions to CPWD to send formal communication for transfer of these public streets/ parks to NDMC.
- (h) After taking over of these roads by NDMC the care and maintenance has got transferred to NDMC and there is an immediate need to maintain these roads in a proper condition so as to avoid inconvenience to the residents staying in these colonies.
- (i) Since the condition of these roads is extremely bad so there is an immediate need to carry out the upgradation of these roads as was decided by the Council during its special meeting on 03 Sep.'09 & regular meeting on 15 Jan.'10. In general whatever roads/ assets are taken over by NDMC for care and maintenance NDMC maintains these areas/roads to acceptable standards.
- (j) Besides the redevelopment plan of these colonies is yet to be drawn by CPWD and may take several years to materialize & for execution on the ground & the residents of the area cannot be made to suffer on account of non-maintenance of these colony roads. It is against this background only that Council took a decision on 03 Sep.'09 to take up the works by NDMC itself out of its own funds with necessary provision to be made in the budget 2010-11 and revised estimate 2009-10. However, Council has to take a decision against backdrop of CPWD

response as stated in para (f) above vis-à-vis hardships & inconvenience faced by residents in these colonies.

Based on the earlier decision of Council on 03 Sep.'09 & 15 Jan.'10 the tenders were invited through e-tendering system with the date of opening as 09 Jul.'10. The details of eligible financial bids received are as follows:-

- (I) M/s Sanjeev Kumar & Bros. is the lowest bidder at 0.08% below the estimated cost of Rs.5,74,87,953/- against the justification 6.94% above the estimated cost with the tendered amount of Rs.5,74,39,093/-.
- (m) The rates quoted by the lowest bidder after scrutiny by Planning have been found to be reasonable and recommended for acceptance by the Council.
- (n) The Finance Department has concurred the proposal for award of work to lowest bidder i.e. Sanjeev Kumar & Bros.
- (o) The extended validity of tender is upto **15 Jan.'11**.

4. Detailed Proposal on the subject/ project

- (a) HDPE pipe ducts for laying of Elect./ communication cables.
- (b) Precast RCC pipe 300 mm dia for drainage.
- (c) Ready mix concrete M-10 & M-40.
- (d) Precast RCC manhole covers, gully chambers, manholes, RCC works etc.

5. Financial implications of the proposed project/subject

The financial implications of the proposal works out to Rs.5,74,39,093/-.

6. Implementation schedule with timeliness for each stage including internal processing

The schedule time for completion of project is twelve months after award of work.

7. Comments of the Finance department on the subject

The Finance Deptt. vide diary No.2126/ Finance/R-Civil dated 08 Oct.'10 & 2335/Finance/R-Civil dated 08 Nov.'10 has concurred the proposal with a comment that incurring expenditure on roads/ lanes not transferred to NDMC, particularly in the light of CPWD's response needs to be looked into again as observed by FD in the instant case as well as in similar other cases. Taking this view of FD department may place the matter to the Council for consideration & decision as proposed. FD vide No.3237/PS/FA/D/10 dated 08 Dec.'10 has seen the agenda.

8. Comments of the department on comments of Finance Department

- (a) The office of Director General (Works), CPWD vide letter No. 7/17/07-W.II/DGW dated 01 Jan.'10 has intimated that it is not advisable to vest the streets & parks with NDMC as these colonies are to be redeveloped as per the provisions of new master plan norms which may necessitate a complete realignment of roads & change in layout plan.
- (b) After taking over of these roads by NDMC the care and maintenance has got transferred to NDMC and there is an immediate need to maintain these roads in a proper condition so as to avoid inconvenience to the residents staying in these colonies.
- (c) Since the condition of these roads is extremely bad so there is an immediate need to carry out the upgradation of these roads as was decided by the Council during its special meeting No. 06/2009-10 on 03 Sep.'09. In general whatever roads/ assets are taken over by NDMC for care and maintenance NDMC maintain these areas/ roads to acceptable standards.
- (d) Besides the redevelopment plan of these colonies is yet to be drawn by CPWD and may take several years to materialize & for execution on the ground & the residents of the area cannot be made to suffer on account of non-maintenance

of these colony roads. It is against this background only that Council took a decision on 03 Sep.'09 to take up the works by NDMC itself out of its own funds with necessary provision to be made in the budget 2010-11 and revised estimate 2009-10. However, Council has to take a decision against backdrop of CPWD response as stated in para (a) & Finance Department observations at para-7 above vis-à-vis hardships & inconvenience faced by residents in these colonies. However in similar case of West Kidwai Nagar Council has taken a decision to carry out such works keeping in view of severe hardship faced by residents of the area.

- **3. Brief History of the Proposal:** This is a case for the procurement of 15 Kms. LT XLPE cable of size:400 sq.mm/3.5C duly ISI marked was processed against various estimates sanctioned by CE(E-II) and council.
- **4. Detailed Proposal of the Subject:** Tenders were invited in three bid system through e-procurement system from the manufacturers for the Purchase of LT XLPE cable of size:400 sq.mm/3.5C duly ISI marked by giving due publicity to the NIT as per the codal provisions. In response to the Tender Enquiry, offers of the following six firms were received on due date of opening i.e.30.07.10 on e-portal system.

The firm has offered discount @ 14% at their basic rates. The computed cost after discount for the per Km length of the Cable worked to Rs. 6,81,572.37. The total computed cost for the purchase of 15 Km cable has also been worked to Rs.1,02,23,586.00. The rates of the lowest tendering firm are 15.5% above the estimated cost put to tender based on LPR dt .08.6.10.

3. Brief History of the Proposals:

Council vide in its Resolution No. 07 (P-01) dated 19.05.2010 (Annexure-I See pages **42 - 45**) approved 'Public Art' being made an integral part of the buildings & public spaces in the area of NDMC and directed framing of detailed policy guidelines. Accordingly policy guidelines have been framed. The same are as **Annexure-II (See pages 46 – 53)**.

A budget provision of Rs. 5 crores was to be made for 2010-11 and Rs. 5 crores each year henceforth. This is being done and expenditure in 2010-11 shall not be more than Rs. 5 crores.

Council had also directed the expert committee to examine the idea of installation of the 'Tree' and 'Dwarpal' structures at appropriate locations and give its suggestions, including final cost, for further consideration of the council. The expert committee in its 4th meeting held on 14.07.2010 examined both the proposals. After due deliberation, the committee decided to initially take up the installation of 'Tree' at NDCC-II complex and to take up the proposal of installation of DWARPAL at a later stage. Minutes of the 4th meeting of the expert committee are enclosed as **Annexure-III (See pages 54-55).**

After doing the needful accordingly, a proposal for installation of Public Art in NDMC area viz. installation of the 'Tree' sculpture by artist Mr. Subodh Gupta at NDCC-II complex under the public art policy of the NDMC and to take up the proposal of 'Dwarpal' at a later stage, was put up for consideration. After discussion, the council deferred its decision and the members were requested to go through the proposal and give their suggestions/comments on the subject, by 24^{th} September, 2010. A copy of Council Resolution No. 07 (P-01) dated 15.09.2010 is enclosed as **Annexure- IV (See pages 56 – 58).** Subsequently, Smt. Tajdar Babar, Vice Chairman and Sh. Mukesh Bhatt, Council member opined that the clause mentioned at point (e) "the council may also agree to Mr. Gupta's request that NDMC will not sell the piece of art created by Mr. Gupta. It can, however, be donated to a museum that has been pre-approved by the Artist" may be deleted and also suggested that "at least one Council member be also inducted in committee".

Based on the above, Mr. Subodh Gupta was requested to withdraw the clause regarding the restriction on the sale of the piece of art by NDMC which has been agreed by him.

Regarding the appointment of one Council member as member on the proposed PAAC, it is recommended that Member NDMC and Secretary, Department of Environment, GNCT of Delhi, Sh. Dharmendra may be nominated to the PAAC.

No recommendations/comments were received from other members.

As directed by the Council, the issues were also discussed in the meeting of the expert committee on 10.12.2010 and the committee recommended that (a) the clause related to the

resale of the piece of art be deleted from the proposal of Sh. Subodh Gupta and (b) Secretary, Department of Environment, GNCT of Delhi and Member NDMC, Sh. Dharmendra be nominated to the PAAC.

Minutes of the 6^{th} meeting of the expert committee is enclosed at **Annexure-V** (See pages 59 – 60).

It is worth mentioning here that on 13.12.2010 on the occasion of inauguration of the convention centre Hon'ble Union Minister for Home Affairs, Govt. of India, mentioned how modern sculptures can add to the beauty of the city. He hoped that the Chief Minister, GNCTD and NDMC would find some way in which artists like Aneesh Kapoor and his likes can find a place in Delhi. The current proposal is in line with the views expressed by the Hon'ble Minister.

Costing of the sculpture 'Tree'

Proposal for installation of 'Tree' was received from Mr. Subodh Gupta. The cost proposal received from him is enclosed as **Annexure-VI (See pages 61 – 66)**. The subgroup to scrutinize the proposal received by Mr. Subodh Gupta was approved by the Chairman on 28.7.2010. The subgroup met and deliberated on the proposal. Certain clarifications were also obtained from Mr. Subodh Gupta. After due deliberation the subgroup gave its recommendation vide report dated 30.08.2010. Copy of the report of the subgroup is enclosed as **Annexure-VII** (See pages 67 – 104).

This report of the subgroup was presented before the expert committee meeting held on 3.09.2010. The expert committee discussed the report of the subgroup and also the draft public art policy guidelines. After due discussion the expert committee **recommended the adoption of guidelines of the public art policy by the council.** Regarding the proposal of Mr. Subodh Gupta the committee recommended that:

- (a) That the decision to have a sculpture titled "Tree" from Mr. Subodh Gupta in the premises of NDCC-II will be a unique piece of contemporary art installation for the first time not only in the capital city but also in the country. The concept of Banyan tree created by the artist resonates the lush landscape of New Delhi, symbolizes India's ancient wisdom and highlights the notions of universal sustainability associated with household utensils.
- (b) That the cost price of Rs. 305 lakh plus taxes as applicable quoted by the artist seems reasonable considering the cost of the (i) Production material & assembly (ii) Specialized technicians (iii) Transportation from outside the country as well from within the country (iv) Foundation including finishing and lighting and (v) the reputation and the caliber of the artist among the top Indian artists both nationally as well as internationally.
- (c) That there shall be a Project Monitoring Committee (PMC) to coordinate with the artist on regular basis and to monitor the progress of art work in accordance with the understanding arrived with the artist in terms of agreement to be signed with the artist by NDMC. Further the committee recommends the name of Sh. Kuldeep Singh as the representative of the expert committee in the project monitoring committee apart from officers of NDMC.
- (d) As regards the mode of payment the committee recommends that NDMC may consider to make secured advance to the artist upto 25% of the cost in order to enable him to make the initial investment towards materials & fabrication.
- (e) The council may also agree to Mr. Gupta's request that NDMC will not sell the piece of art created by Mr. Gupta. It can, however, be donated to a museum that has been preapproved by the artist.

(f) NDMC should provide for the upkeep & maintenance of the artwork. In case of any damage the restoration should be got done under the supervision of an contractor approved or suggested by the studio of the artist, all expenses in this regard will have to be borne by NDMC.

Minutes of the 5th meeting of the expert committee is enclosed as **Annexure-VIII (See pages 105 – 106)**.

Rehabilitation of old sewers. **SH:** Desilting and rehabilitation of 838x940mm Egg Shaped barrel at Man Singh Road from Ashoka Road to Q. Point- **Approval of extra item Statement and Revised estimate thereof.**

- 2. Name of Department concerned: Civil Engineering Department (PH Circle).
- 3. <u>Brief History of the subject/ project:</u>. The Administrative Approval / Expenditure Sanctioned amounting to Rs. 8,06,63,000/- for the above mentioned work was accorded by the council vide reso. No. 17(A-11) dated 28.04.2008. After adhering to all codal formalities of tendering process and the approval of the council vide resolution no.15 (A-125) dated 18.02.09, the work was awarded to M/s SPML with tendered amount of Rs. 8,31,06,045/- at 6.53% above estimated cost of Rs. 7,80,08,034/-.

The stipulated date of start and completion were 16.03.2009 and 15.03.2010 respectively. The work was actually completed on 30.08.2010. At the time of framing estimate, the size of the existing egg shaped sewer barrel was taken as 838 X 940 mm on the basis of the data given by Tata consultancy services because actual measurement of size of the barrel was not possible at that time as this was an old trunk running sewer line with lot of silt in it. The sophisticated machineries required for the purpose were not available with the department. However, there is a provision in the contract to access the size of the existing line before carrying out CIPP lining after proper desilting with supper sucker etc. Accordingly the work was taken up and the sewer line was got desilted and CCTV conducted to measure the actual size of the existing barrel which was measured as 976x1369. Because of this variation in size of the sewer line extra amount becomes payable to the agency in accordance with the terms and conditions of the agreement.

The approval in-principle for this extra amount involved was obtained from the competent authority before actual execution of work at site.

Accordingly extra item statement no-2 amounting to Rs. 2,43,40,242/- and Revised PE amounting to Rs.10,61,94,151/- are due for approval by the council as the gross amount of the work has exceeded beyond 10 % of the A/A& E/S of the work.

4. <u>Detailed proposal on the subject/project:</u> As explained in Para 3 above, extra item statement no-2 amounting to Rs. 2,43,40,242/- and Revised PE amounting to Rs.10,61,94,151/- are due for approval by the council. The rates for this extra item has been derived as per the provisions of the clause15 (XX) of Special Condition 2 of the agreement which provides.

"Size of barrel given in schedule of quantity in item no. 1 has been determined by the deptt. in case of any deviation in the size of the barrel found at site, the same shall be paid at prorata basis. The decision of engineer-in-charge will be final."

- Financial implications of the proposed project/subject : The required budget provision has been sought in RE of the current year 2010-11.

Municipal Corporation of Delhi authorities agreed to admit NDMC candidates in Part-I and Part-II of the above examination every year. The office of the Chief Auditor, MCD had been conducting the examination every year since 1978.

MCD vide resolution no.423 dated 03.10.2008 approved discontinuation of this examination now known as S.O.Grade Examination for NDMC candidates. Since then we have been facing difficulty in filling up the posts of AAOs as the feeder channel to the post is blocked. This is because the RR for the post specifies for filling up the post by promotion from Junior Accounts Officer with two year service in the grade in the pay scale of 6500-10500 who have qualified S O Grade examination conducted by Municipal Chief Auditor, MCD.

The Chairman, NDMC vide orders dated 18.11.2008 constituted a Sub-Committee of CAO, Director (Personnel), Director (IT) to review and suggest the appropriate syllabus and the method of examination for NDMC candidates for this Examination.

To facilitate further the filling up the post of AAOs, the RR (enclosed as **Annexure-I (See pages 112 - 113**) needs to be modified to the extent that the exam will be conducted by NDMC or authorized agency.

1 Name of the Subject:

Annual enhancement of licence fee in Palika Bazaar.

2. Name of the Department:

Estate-I Department

3. Brief History of the Subject:

The grievances of Palika Bazar Shopkeepers Association were mentioned during the Council's meeting held on 27.10.10. Chairman had then informed that Director (Estate-I) has been advised to examine the representation of Palika Bazar Shopkeepers Association for deferment of annual enhancement in licence fee. Similarly, Chairperson has also desired that the issue of levying of cancellation charges in respect of units which were found indulging in trade violation during survey undertaken in March, 2008 be examined.

Palika Bazaar is a prestigious air conditioned underground market consisting of 402 units which are regulated through 5 trade zones. Policy for annual enhancement of licence fee in this market was approved by the Council vide Resolution No. 1 (L-4) dt. 29.08.07 which provides that licence fee in this market would be increased by 10% bi-annually w.e.f. 01.04.2008. Accordingly, annual enhancement of this market was due on 01.04.10.

Upgradation/Renovation of this market which was long due was taken up in November, 2009 and broadly included replacement of air-conditioning system, transformers, flooring, change of shutters, new false ceiling with CCTV, provisions of escalators and x-ray machines etc. With a view to expedite the work, a weekly off and restriction on working hours for the market were also was also prescribed, in consultation with the Market Association. As per the report of E.E. (BM-II) Electric who is the Nodal Officer coordinating the renovation work, though the major works are over yet the remaining works are likely to be completed by 31.12.10.

Palika Bazar Shopkeepers Welfare Association (Regd.) for quiet some time have been representing:

(a) That there has been steep fall in the business and therefore, the bi-annual enhancement of licence fee w.e.f 01.04.10 may be frozen for two years.

Recommendations in this regard have also be received through Members of the Council, who have forwarded representations of the Association.

4. Detailed proposal on the Subject:

It is obvious that considering the nature/quantum of renovation/upgradation work undertaken, normal business in the market must have suffered.

It is therefore proposed that though bi-annual enhancement for all the units may be effected from 1^{st} April, 2010 in books but it may actually be realised w.e.f. 01.04.2011. By doing so NDMC may not loose on licence fee on cumulative basis.

5. Financial implication of the proposed Subject:

We receive about Rs. 5.50 crores as licence fee from Palika Bazaar per annum and therefore, broadly speaking rebate proposed would result in waiver of about Rs. 55 lakhs.

6. Implementation schedule with timeliness for each stage including internal processing:

"After completion of the business, an issue regarding extension of the ongoing tax rebate scheme of NDMC was also mentioned with the permission of the Chair and the Council resolved to extend the scheme for one more month, i.e. upto 31st January, 2011".

THE FOLLOWING RESOLUTION PASSED BY THE COUNCIL IN ITS MEETING DATED 29.12.2010:-

"A point regarding clarification on the method of fixing of the justified rates also came up before the Council. The Council directed that the departments should strictly follow the existing procedure i.e. the Departments should decide the justified rates criterion before opening of the financial bid which may be kept in a sealed cover till the opening of financial bid/tender. The same should be opened after opening of the financial bid/tender and requisite comparisons be made accordingly".
