**FIRST MEETING OF THE NEWLY CONSTITUTED COUNCIL
OATH TAKING BY MEMBERS**

In exercise of the powers conferred by Sub-section (1) of Section 3 and Section 4 of the New Delhi Municipal Council Act, 1994 (44 of 1994), the Ministry of Home Affairs, Govt. of India, vide their Notification dated 5th September, 2014 have reconstituted the Council **(See Annexure at pages 3 – 8)**.

Hon'ble Lt. Governor / Administrator of the National Capital Territory of Delhi has convened the first meeting of the Council, under Section 22 of the said Act, on 06.09.2014 at 9-00 A.M.

It is proposed that Hon'ble Lt. Governor / Administrator may administer oath to the Chairperson, Vice Chairperson and Members of the newly constituted Council, as per the provisions contained in Section 7 of NDMC Act, 1994.

COUNCIL'S DECISION

The Notification dated 5th September, 2014 issued by the Ministry of Home Affairs, Govt. of India, regarding reconstitution of the Council was read out.
