A meeting of Town Vending Committee (TVC) convened on 08.07.2020 at 11:30 AM at 1st Floor, Convention Center, NDCC Phase-II, Jai Singh Road, New Delhi and the meeting attended by the following members of TVC :

2. The Agenda items were discussed and decisions have been taken as follows:-

i) **Starting of survey of street vendors by engaging the agency shortlisted by GNCTD.**

a) It was informed that:

(i) a survey in New Delhi Municipal Council (NDMC) area was initiated on 26.09.2018 to ascertain the factual position of number of street vendors as of the date. However, since the GNCTD Street Vendors (Protection of Livelihood and Regulation of Street Vending) Scheme was not notified at the time of survey, the GNCTD had termed the survey as invalid and now there is a need to conduct fresh survey;

(ii) the manner of conducting survey is provided in the scheme notified by GNCTD on 03.10.2019. and GNCTD has selected two agencies on 26.02.2020 for conducting survey in Delhi to assist TVC in survey process.; and

(iii) the Notice for selection of agencies endorsed to NDMC in June, 2020.

b) Smt. Meenakshi Lekhi, Hon'ble MP (Lok Sabha), New Delhi Constituency and Member, NDMC came and attended the meeting for some time and suggested the following:-

i) the basis of cancellation of survey carried out by New Delhi Municipal Council in the year 2018 by the GNCTD as conveyed vide Minutes of Meeting dated 12.11.2018 of Minister of Urban Development (Reference No. OSD(UD)/Min.Health/2018-19/10361-69 dated 14.11.2019 that no valid TVC meeting was held and the survey was started without any approved Scheme may be re-examined in the light of Street Vendors Act, 2014, Rules and Scheme..

ii) the nomination of NGOs, MTAs and RWAs in the TVC by GNCTD vide Notification No.F13(230)/UD/MB/2018/Pt file 1/(CD No.021517474)/1922 dated 17.09.2019 may also be re-considered in terms of Act, Rules and Scheme.

iii) if there is a need to conduct fresh survey, it can be done but cutoff date should be the date on which the survey in the year 2018 was completed.

c) Some Members of TVC raised the issue of representatives of Yuva ar National Hawkers Federation in the meeting and it has been agreed to examine the same under the relevant rules.

d) It was also informed that there is a suggestion from IGSSS, one of the TV nominated Member that –

"The Survey should ideally not be done now as thousands of vendors have left Delhi and are unsure about the rules for vending: The survey should not be conducted now or perhaps for the next 3 months as the entire country is facing a deadly pandemic and thousands of migrant workers, a significant number of whom are street vendors, have returned to their villages/states at this time or are not being allowed to vend by the authorities. Conducting the survey now and then denying them their right to practice their livelihood later when they return to the city will be unfair. All this when the disaster management act is invoked in the country."

e) It was decided to defer the agenda item.

ii) Issue related to extending the Micro Credit Facility to Street Vendors under the Scheme PM - Street Vendors Aatma Nirbhar Nidhi (PM-SVANIDHI).


(a) It has been informed that PM-SVANIDHI is a special Micro Credit Facility for street vendors and it shall be implemented upto March, 2022. The scheme is to facilitate working capital loan up to Rs.10,000 at subsidized rate of interest, incentivize regular repayment of loan and reward digital transactions. The initial working capital of up to Rs.10,000/- with interest subsidy on timely/ early repayment @ 7% and loan applications are to be submitted online on <http://pmsvanidhi.mohua.gov.in/>. Further, no collateral security is required and the Town Vending Committee has to play a very important role in identification of beneficiaries. Small Industries Development Bank of India is the Implementation Partner of the Scheme.

b) As per the Scheme guidelines, a Committee at the level of NDMC, to sponsor loan applications and monitor implementation of the Scheme, is to be constituted. It was informed that the Chairman, NDMC has nominated Shri D.P. Singh, IAS, Director, NDMC as Chairperson of the Committee and there is a need to finalize the names of 3 non-official members of TVC.

(c) It was decided that selection of 3 non-official members of TVC may be done by preference voting amongst elected members and as a result the names of Shri Dinesh Kumar Dixit, Smt. Ruby Kumari Mishra and Mohd Hayat were finalized.

(d) The Chairman, TVC requested all the TVC members to disseminate the information about the PM-SVANIDHI scheme amongst the street vendors and take pro-active action for facilitating the implementation of Scheme.

The meeting ended with vote of thanks to Chair.
