Minutes of the Committee constituted to consider cases for appointment of dependent of deceased NDMC employees on compassionate grounds

There are 32 vacancies (24- Category C and 08 Category D). In the last meeting of the Committee held on 12.05.2016 for considering the case of compassionate appointment, a total of 28 candidates were recommended for appointment. However, due to discrepancies observed in the evaluation process, the recommendations were cancelled and Chairman, NDMC had directed for fresh evaluation. Accordingly a circular was issued on 23.02.2017 inviting applications from all the eligible candidates.

2. For the purpose of Screening Committee meeting, all the cases where death of employee had occurred before 31.08.2016 have been considered. Based on the available record, the assessment of the dependent who has submitted application for compassionate appointment has been made. To make procedure fair and transparent, a concerted efforts were made to get the pension and terminal benefits of all the deceased employees cleared. However, there are around 25 cases where pensionary benefits have not been settled and as such fair evaluation cannot be done.


3. As, in terms of approved criteria, amount of family pension and terminal benefit that have been paid is crucial for preparation of merit for considering the case for compassionate appointment, all the cases where pension papers are either pending and have not been submitted by the dependent employee have not been considered. While evaluating each candidate differences have been observed in information furnished by the candidate and those recommended by the Welfare Department.

4. In evaluation in few cases the value of property owned by the deceased employee has not been indicated. In such cases, the estimated value of the property has been included in the evaluation.

5. The Committee for considering the cases of compassionate appointment evaluated the claim of dependent deceased Government employees for appointment on compassionate ground. The Committee adopted following criteria:-
