2.	The rates be submitted along with a certificate of confirmation that the offers rates are the same as quoted for the other bodies like MCD, DDA, DJB, Public Sector Undertakings and Autonomous bodies.				
3.	In case it comes in the notice of NDMC that the newspapers has quoted the higher rate to NDMC in comparison to rates offered to other bodies, the NDMC has right to stop the advertisement in future for the concerned newspaper.				
4.	Any surcharge in respect of percentage over and above the usual rates as quoted by the newspaper will not be accepted.				
5.	The days of the specific advertisement columns for employment or othe advertisements be clearly mentioned in the separate column.
