

## APPROVED POLICY FOR ISSUE OF PARKING STICKER

As approved by the Chairperson the sub-committee conducted its meeting in the office of Dir. (PR/Transport) on 6<sup>th</sup> & 10<sup>th</sup> December 2012 in which following were present: -

- i. C.E. (C-I)
- ii. C.E. (C-II)
- iii. C.E. (Elect.)
- iv. MOH
- v. Dir. (Enf.)
- vi. Dir. (Hort. North)
- vii. Dir. (Hort. South)
- viii. Dir. (PR/Transport)
- ix. Fire Officer
- x. CSO
- xi. CMO (North)


In the meeting various aspects pertaining to issue of NDMC Parking Stickers were discussed and it is opined as under: -

- a. As pointed out by the Chairman EPCA about issue of Parking Stickers to shopkeepers, henceforth; no parking sticker to be issued to Market/Shopkeeper/Traders Association.
- b. Most of the NDMC employees are performing duties in field/entire NDMC area and on every occasion making payment from own pocket for parking charges of his/her official/personal vehicle will neither be practical nor in the interest of NDMC.  
Therefore; as per practice the issuing of NDMC parking stickers to all employees needs to be continued, albeit; on the recommendation of the concerned HOD.
- c. Similarly prevailing practice of issuing Parking Stickers to ex-NDMC (Group 'A') Officers be continued,
- d. The quota restriction for Council Members and Director, Public Relations (for media/press people and cases recommended by HODs must be adhered to strictly which is as follows: -


| S.No | Person to whom issued through Director (PR) | 4-wheeler | 2-wheeler |
|------|---|-----------|-----------|
| 1.   | Director (PR) for Press/Media               | 80        | 20        |
| 2.   | Vice-chairperson                            | 30        | 10        |
| 3.   | Member (KST)                                | 30        | 10        |
| 4.   | Member (AA)                                 | 30        | 10        |
| 5.   | HOD (each)                                  | 10        | 5         |

HODs will only recommend for eligible personnel/category

- e. The practice of providing parking stickers to Cent./State Govt., PSU, Govt. body/enterprise/ undertaking should be continued as NDMC requires to function in close co-ordination with all of them. Moreover; this is just a small/token privilege extended by NDMC to other Govt. bodies and it is highly unlikely that such vehicles will overcrowd the parking lots of NDMC.


