Sub: S/R of roads in NDMC area

SH: Upgradation & Improvement of Environs of Khan Market (Phase-I)

2. Name of the Department

Civil Engineering Department, EE(CP) (C-I)

3. Brief history of the subject/project

- (a) There was an outstanding demand of Khan Market Traders Association for upgradation & Improvement of environs of the market. Several discussions were held on this matter with various stakeholders and it was decided by the Competent Authority that upgradation & improvement plan of Environs of Khan Market i.e. improvement of corridor, parking, signages and middle service lane be taken up on priority.
- (b) Accordingly, it was proposed to develop Environs of Khan Market in two phases. Improvement of verandah in front of shops, parking area adjoining carriageway and improvement of drainage etc. to be taken up in phase-I & improvement & upgradation of middle lane between two blocks to be taken up in phase-II as extensive discussions are required to be held with various stakeholders.
- (c) The Preliminary Estimate for Phase-I was approved by the Council vide Agenda Item No. 03(A-56) dated 15/22 Jul.'09 for Rs. 1,59,08,000/-.
- (d) The tenders were opened on 17 Sep.'09 through e-tendering system & eight eligible tenders were received the details of which are as follows:-

- (e) M/s Bipin Kumar is the lowest bidder at 10.65% above the Estimated Cost of Rs.1,41,87,738/- against the justification 10.38% above the Estimated Cost with the tendered amount of Rs.1,56,98,640/-.

4. Detailed proposal on the subject / project

- (a) Brickwork in toe wall of the verandah, PCC 1:5:10.
- (b) Ready Mix Concrete in the carriageway with granite cobbles on one side towards the shops and concrete pavers towards the wall after scarifying the existing Bituminous surface. The concrete pavers are proposed to be laid towards the wall as there are lots of services running below it & same pattern would be followed on other sides of Market also.
- (c) Granite in flooring and cladding.
- (d) Precast concrete Kerbstone & interlocking pavers, 80 mm thick.
- (e) Installation of general road & directional signages & construction of aesthetically designed planters in front of parking (Opposite Lok Nayak Bhawan).
- (f) Rain water pipes, electric & communication cables are proposed to be laid in pipes under the floor/ road.
- (g) Construction of gully chambers, improvement of drainage etc.

2. Name of the Department

Civil Engineering Department, CP Project Division.

3. Brief history of the subject/project

- (a) During the meeting held by Chief Secretary, Govt. of Delhi regarding Transport Plan of CWG-2010 on 20 Jan.'09 a decision was taken to take up Subramaniam Bharti Marg for streetscaping as the road would be used for park and ride facilities for spectators coming to National Stadium.
- (b) The Preliminary Estimate was approved by the Council vide Agenda Item No. 09(A-79) dated 30 Sep.'09 for Rs. 2,62,00,000/-.
- (c) The tenders for Civil and Electrical Works were opened on 22 Sep.'09 through e-tendering system. Two eligible tenders were received the details of which are as follows:-

- (d) M/s KBG Engineers was the lowest bidder at 37.29% above the Estimated Cost of Rs.2,32,01,533/- against the justification 12.52% above the Estimated Cost with the tendered amount of Rs.3,18,53,631/-. Since the rates quoted by the lowest bidder were found to be on higher side so after approval by the Competent Authority the negotiation was conducted with the lowest bidder through Negotiation Committee. After offering a rebate of 7% on his earlier quoted rates the negotiated offer worked out to 27.60% above the Estimated Cost with the tender amount of Rs.2,96,23,877/-. Since there was a still difference of more than 10% between the negotiated rates and the justified rates as such tender was recalled after approval by the competent authority.

- (e) The tenders in second call were opened on 06 Nov.'09 through e-tendering system & two eligible tenders were received the details of which are as follows:

- (g) The rates quoted by the lowest bidder after scrutiny by Planning have been found to be reasonable and recommended for acceptance by the Competent Authority.

- a) Based on recommendations made by a high level committee appointed in 1993 by the Ministry of Surface Transport, and after detailed discussion of the report, the Ministry of Surface Transport, Govt. of India decided the renewal cycle for various categories of roads, according to the traffic intensity in urban area. In the light of these recommendations, various roads in NDMC area were classified by the Civil Department for the purpose of their surface treatment and the periodicity of such treatment.
- b) Accordingly, the matter was placed before the Council and the periodicity of resurfacing was approved by the Council vide Resolution No. 6 dated 13 May'94 (**Annexure 'A' See page 44**) which is as follows:-

Besides, with the advent of new technologies different materials are available in the market to improve the performance of the resurfaced roads. These technologies/ materials have been adopted by NDMC on its roads in the recent past. Stone Matrix Asphalt has been used on some roads/roundabouts under RIP-I/II and it is proposed to be used in future also due to its improved performance in light of manifold increased in the traffic on the roads. Similarly Micro-surfacing i.e. Cold Mix resurfacing has also been used on NDMC roads under RIP Phase-I & II which has given good performance so far. All these technologies have been introduced in consultation with Central Road Research Institute (CRR I).
- e) Due to factors such as normal wear & tear of road surface, laying of utilities, increased commercial activity resulting in exponential growth in number of vehicles etc. the roads surface gets worn out very fast. Also due to introduction of new materials and exponential growth of the traffic on the roads a need has arisen to review the periodicity of resurfacing of roads using the polymer/ crumb rubber modified bitumen instead ordinary grade bitumen and with Micro-surfacing using cold emulsion. Besides all the main roads, colony roads, service roads are being got evaluated by CRR I to exactly give us the type of resurfacing to be carried on these roads before framing of Estimates. So there is a need to review the periodicity of resurfacing of roads in NDMC area so as to maintain these roads to the best standards.
- f) The defects liability period for contracts of Riding Quality Improvement Programme is at present is kept five years for dense carpeted roads. The roads/ lanes are not resurfaced during defect liability period of the contract. As and when need of repairing of roads/ lanes during defect liability arises the same is got done from the contractor concerned or at his risk & cost.

- g) For ascertaining the periodicity of resurfacing of roads in different organizations, letters were written to PWD, MORTH, MCD & Cantt. Board requesting them to intimate the life / defect liability period of dense carpet with modified bitumen like CRMB/ PMB.
- h) PWD vide their letter No. E-in-C/W/MOR/09/4521 dated 06 Oct.'09 (**Annexure 'C' See page 49**) has intimated the defects liability period in case of resurfacing of PWD roads with CRMB as five years.
- i) MORTH vide their letter No. RW/NH-33044/10/2000-S&R dated 26 Sep.'02 (**Annexure 'D' See pages 50 - 55**) have indicated that the renewal of roads having more distress & warranting resurfacing only & sections having been strengthened under earlier programmes and the surface condition is in reasonably fair condition and renewal is warranted to preserve the surface and provide better riding quality the proposed renewal is expected to last atleast for a period of three years with use of modified Bitumen. But the specifications for renewal in this case are 25 mm SDBC/ BC which are different from the specifications being adopted by NDMC based on CRRRI recommendations.
- j) MCD vide their letter No. D/1133/SE(P)-I/2009 dated 08 Sep.'09 (**Annexure 'E' See pages 56 - 61**) have indicated the defect liability period as five years for bituminous of grade 60/70 mm and seven years when CRMB-60 binder has been used.
- k) The office of Cantonment Board vide their letter dated 08 Sep.'09 (**Annexure 'F' See page 62**) has offered no comments as Delhi Cantonment Board has not resurfaced roads with CRMB/ PMB.
- l) The case was referred to CRRRI and CRRRI vide their letter No. CRRRI/PED/NDMC/RIP/2009 dated 06 Jul.'09 (**Annexure 'G' See pages 63 - 64**) has given following comments/ recommendations:-
 - (i) It is extremely difficult to indicate single design life of resurfacing laid with CRMB-60/ PMB-40 since it would be largely influenced by several factors prevailing in a given operating environment viz. type of subgrade, existing surface condition prior to resurfacing, structural adequacy of the road, extent of traffic volume and axle loading patterns (particularly of

heavy commercial vehicles), climatic conditions (minimum, maximum & intensity with regard to temperature and rainfall), quality of materials used and quality control exercised during execution of work, workmanship, quality of routine maintenance applied (patching, sealing of cracks), drainage conditions & depth of water table etc.

- (ii) None of the studies conducted so far in the country on the performance/ life of pavements laid with modified bitumen vis-à-vis conventional bitumen have been able to precisely suggest/ recommend the specific life of surfacing laid with CRMB-60/ PMB-40. The design life of resurfacing cannot be specified in isolation and that it has to be related to terminal level of service which can be defined in terms of, say, Roughness (say $\geq 4000\text{mm/km}$), All cracking $\geq 25\%$, total surface distress $\geq 25\%$ or Rutting $\geq 20\text{ mm}$ or in any other form.
- (iii) It is now very well established that Modified Bitumen, in general, extends the service life of pavement which is accomplished by controlling the cracking, rutting and hardening of the pavement surface due to oxidation and reducing the damage caused by water etc. The advantages of modified bitumen over conventional bitumen include the following:-
 - Lower susceptibility of daily and seasonal temperature variations.
 - Higher resistance to deformation at elevated pavement temperature.
 - Better age resistant properties.
 - Higher fatigue life of mixes.
 - Better adhesion between aggregates and binder.
 - Prevention of cracking and reflective cracking.
 - Overall improved performance and service life in extreme climatic conditions and under heavy traffic conditions.
- (iv) As per section 6.10.1 (page 37) of "Report of the Committee on Norms of Maintenance of Roads in India", published by IRC in 2001" (**Annexure 'H' See page 65**) the life of 40 mm BC for heavy trafficked roads in urban conditions is indicated as four years. This design life is for the neat/ conventional bitumen because use of modified bitumen at that point of time (in 2001) was not in practice in India.

- (v) As per section 6.16.1 (page 44) of the above mentioned report (**Annexure 'I' See page 66**) modified bitumen is expected to give 50 to 100% higher life of surfacing depending upon the degree of modifications and type of additives used. Trial studies conducted by various agencies have reported that the use of modified bitumen is cost effective. It is possible that properties of modified bituminous mixes get improved and life of pavement gets enhanced, particularly where high traffic loads are expected.
 - (vi) Keeping above in view, it may be inferred that design life of resurfacing laid with modified bitumen on heavily trafficked roads, under Delhi climatic conditions, is expected to be minimum 5 (five) years. There is, however, a strong need to conduct a scientific/ systematic performance study to authenticate such a statement.
- m) In case of Stone Matrix Asphalt & Micro-surfacing CRRRI vide their office letter No. CRRRI/PED/NDMC/2009-10 dated 21 Oct.'09 (**Annexure 'J' See pages 67 - 68**) has given following recommendations:-
- (i) There are no definite/ universal conclusions with regard to the specific/ fixed service life of any specification – be it Stone Matrix Asphalt (SMA) or Microsurfacing. The life of any surfacing depends heavily on the operating conditions in which it is subjected to viz, environmental conditions, drainage, traffic volume and axle loads and structural adequacy of the pavement. In addition, the quality of constituent materials used during execution of job and the workmanship/ construction quality achieved also have significant influence on service life of a particular surfacing.
 - (ii) The life of SMA is, no doubt, more than the conventional dense graded asphalt mixes. The service life of SMA for operating conditions prevailing in NDMC area is expected to be more than five years. It is pertinent to note here that SMA has been laid for the first time in India on Zakir Hussain Marg in Delhi about 3 years back and it is still performing very well with no surface defects noticed so far. Therefore, a service life of minimum five years can be considered as safe for SMA.
 - (iii) With regard to the service life of Microsurfacing, the literature says that it can last even upto 6-7 years. It should be noted at this stage that microsurfacing is basically a preventive maintenance treatment and it

doesn't add to any structural strength to the pavement. The optimum service life of microsurfacing can be realized only when the pavement is structurally sound. The various influencing parameters, as stated in para (ii) above are equally applicable to the microsurfacing also. Microsurfacing treatment was applied for the first time in India on Prithvi Raj Road in NDMCA area in the year 2000-2001 and it is still giving good service. Since then a number of roads have been laid with microsurfacing not only in NDMC area but in other parts of Delhi as well and practically all of them are performing quite well. Therefore, we believe that microsurfacing is expected to give a service life of about 4-5 years atleast on NDMC roads which are, in general, structurally sound.

- (iv) No systematic performance studies have been conducted so far in India with regard to determining the service life of microsurfacing and SMA. However, the service life, as indicated above for SMA & Microsurfacing may be considered as safe. We should also keep it in mind that service life of a surfacing has to be linked to the terminal level of serviceability which can be expressed in terms of roughness, rutting or cracking etc. and needs to be defined by the Road Agencies themselves.
- n) In view of position explained above & based on recommendations of CRRI & norms followed by PWD it is considered necessary to review the periodicity of resurfacing of main roads, lanes, colony roads & service roads etc. in NDMC Area based on evaluation carried out of the surface conditions by expert agencies like CRRI/ IIT/ Delhi College of Engineering etc. & shall be as follows:

4. Detailed proposal on the subject/project:

Based on the decision taken by the MHA, a letter no. F.No. VI. 23014/289/2009-VS dtd. 26.11.09 from Sh. N.I. Chowdhury, Dy. Secy. to the Govt. of India, Ministry of Home Affairs, PM Division, (CWG Cell) , addressed to the Secretary, Ministry of Urban Development, Secretary, MYAS, Chief Secretary, GNCT of Delhi & Chairman, NDMC was received on the subject of "Contract Agreement for the installation of Integrated Security System at all 26 Games Venues for the Commonwealth Games 2010" with copy of the final agreement for two venues (Talkatora Indoor Stadium & Shivaji Stadium) of NDMC. The contents of the letter is reproduced as under:

ITEM NO. 13 (E-6)**01. Name of the subject/project****Subject: - Opening of a Dental Clinical at Dharam Marg.****02. Name of Department & Other Concerned Departments.****Medical Department.**

03. Brief History: - A 15 bedded maternity & child welfare centre and an allopathic dispensary were situated on this plot of land measuring 3183.824 sq. meters at Dharam Marg till the year 2000. There also existed a few staff quarters for essential duty staff of this MCWC centre on this land. The council vide its resolution No. 3 (V) dated 17.05.2001 approved a 50 bedded state of the Art Maternity Hospital along with essential duty staff quarters by demolishing the old building (**Annexure-I See pages 111 - 112**).

The work of the proposed project was awarded on 18.07.2003. The expected date of the completion of the work was 17.01.2005. But construction of one floor of the proposed hospital building and essential duty staff quarters had to be dropped in between in the light of the objections of Delhi Urban Art Commission on the ground coverage and the FAR of the building in the proposed drawings of the project. The resultant reduction in the covered area and the DPCC requirement of installation of various facilities for the proper treatment and disposal of Biomedical/Hospital waste raised doubts on the viability of the project. In addition, it was apprehended that the residents of this elite area might object/oppose to the installation of biomedical waste treatment facilities. Consequent of this, in a review meeting in February 2004, it was proposed that the construction of a 50 bedded maternity hospital be abandoned.

Subsequently, a state of the Art Radio Imaging Diagnostic Centre with provision of MRI, CT Scan and Mammography on a PPP model was proposed. The council vide its Resolution 04(A-14) dated: - September 2006 took a serious view of the proposed change in the scope of work (**Annexure-V See pages 124 - 129**). Consequently a subcommittee comprising of Hon'ble members of NDMC was proposed to suggest optimal use of the space after site inspection. The recommendations of the proposed sub-committee were (**Annexure-VI See pages 130 - 131**).

- i) Setting up of a state of Art Radio Imaging Diagnostic Centre with facility of MRI, CT Scan & Mammography at Dharam Marg. The facilities should be available to the employees and their dependants free of cost.
- ii) Opening of Allopathic, Ayurvedic & Homeopathic dispensaries.

But this proposal was also rejected in the light of the following observations of the Law Department.

- i) "These are obligatory functions of NDMC and does not permit the facility to be made available by any other party on PPP basis.

- ii) In the light of the provision of NDMC act, it needs to be examined as to whether NDMC can set up such facilities in any other building in which construction & providing of the equipments is by third party and not an involvement of NDMC”(Annexure-II See page 113).

A high powered sub committee was constituted in May 2008 to suggest appropriate use of the said premises (**Annexure-III See pages 114 - 116**). The said subcommittee suggested consolidation of existing primary health physical infrastructure & qualitative improvement of delivery services rather than setting up of newer services and its recommendations were: - (**Annexure-IV See pages 117 - 123**)

- i) Shifting of Allopathic and Indian System of medicine stores from Veterinary Hospital Complex to the basement of the Dharam Marg Building.
- ii) Shifting of MCW Centre from Aanchal.
- iii) Opening of Allopathic, Ayurvedic and Homeopathic dispensaries.
- iv) Opening of full fledged Dental Clinic/Hospital.

04. Detailed Proposal of the subject: - All the units proposed for shifting i.e. stores (Allopathic and Indian System Medicine) and MCWC, have already been shifted to this building. The Allopathic, Homeopathic and Ayurvedic dispensaries have also been commissioned. The present proposal is for the opening of a full fledged Dental Clinic/Hospital.

The department has proposed to open 4 Dental Specialities on the first floor of the building: - i.e.

- i) Periodontia.
- ii) Oral and Maxillo Facial Surgery.
- iii) Oral Medicine.
- iv) Endodontics.

The committee noted that M/s MGRM net Ltd has achieved the highest Total score marks on the basis of CQCCBS process adopted for said project and recommended that it may be awarded the works after negotiations. The case was then forwarded to Vigilance Department and Finance Department for advice. The Finance department advised for preparation of justification of rates before going for negotiation. The department prepared the justification of rates on the basis of expenses incurred educational institutes and schools. The justified amount of Rs. 7,17,00,000/- was taken by the committee for the basis of negotiation. The matter for Administrative approval and Expenditure sanction for implementation of EIP in NDMC schools was placed before the council dated 28-10-09 and was deferred as the Council members desired that the system followed for the selection may be explained and a

detailed presentation be made by the committee for EIP.

After presentation, the Council members wrote to the Chairman, NDMC that earlier projects have not been too successful and while appreciating the currently proposed project expressed that that detailed facts and commitments about the project be brought again before the council for consideration and decision. To this the department has to submit that :

- a) The Educational Integration Project (EIP) is based on SAAS (Software as a Service) Model on a per month per user charge basis as given below. Under this model, the Service provider provides the services to the client and gets paid for what has been achieved after the submission of reports for successful implementation from the concerned Department/HOD/Principal of Schools. Hence the overall payment would depend upon the number of actual smart cards in operation.
- b) The EIP shall work in Phases. Initially EIP will be implemented in approx 10 schools as a pilot phase. The project review committee will monitor the progress of EIP. Only after the satisfactory reports from the Project Review committee, rest of the schools may be taken up for the implementation.
- c) The existing IT infrastructure school as brought out by the members like computer and networking can be utilized in the EIP.

5. Financial implications of the proposed/subject

Yes, the estimated cost of the project would be Rs. 7,17,00,000/-(Inclusive of all taxes). The Expenditure would be Charged from New Head of Account D.1.2.11 mapped to New Chart of Account s 82.230.59.22 Expenditure in respect of Navyug Schools booked under the HoA D.1.11 (82.260.10.01. The Details are here under:

A brief presentation on Educational Integration Project of NDMC Schools was given to Council members on 05-11-2009 in the Council room, Palika Kendra by the Department on behalf of Project Committee-EIP. The Council Members asked the department to submit the copies of guidelines issued by Ministry of Finance on Combined Quality Cum Cost Based System (CQCCBS) for evaluation of tenders and Technical specification of the project, which were provided to the Council members to facilitate the decision. The Council members asked to bring the project before the council for consideration and decision.

Council vide Resolution No. 33 (A-100) has resolved the following:-

"Resolved by the Council to accord revised administrative approval and expenditure sanction to the estimate amounting to Rs.4,41,52,200/- for the work of remodelling of office space for Commercial Department at Shaheed Bhagat Singh Place subject to the condition that a certificate to the effect that all the office equipment/furniture to be supplied and installed will be the fire retardant, will be put up on record by CE (C-II) The Fire Officer of NDMC will counter check and verify that the material supplied was fire retardant".

The matter was discussed with the Fire Officer before execution of work with reference to the aforesaid resolution of the Council and it was informed that the fire retardant furniture is only required for school building and is not mandatory for the office building. Accordingly the case was processed for accord of approval of the competent authority for the modification of the resolution of the Council. The case was seen by the F.O.-cum N.A. submitted his-report as under:-

"With reference to Reso. No. 33 (A-100) for procurement of balance furniture from M/s. Godrej subject to the condition that a certificate to the effect that all the office equipment/furniture to be supplied and installed will be fire retardant, will be put on record by CE (C-II).

In this regard it is informed that as per Clause No. 3.3.1 of National Building Code of India, 2005 for buildings 15M in height or above non-combustible materials should be used for construction and the internal walls of staircase enclosures should be of brick work or reinforced concrete or any other material of construction with minimum of 2 h rating.

The Fire retardant furniture is required in the case of schools only as per the circular issued by Director (Education) vide No. 262-362 dated 17.01.2005 and further sent to Chairperson, NDMC by the Principal Secretary (Home) on dated 22.07.2005 which read as under:-

Clause-9. Non combustible material and/or material with surface flame spread of Class A rating shall be used for erection of false ceiling, wall panelling etc.

Clause 14-All furniture of the school including chairs and tables must be got painted with fire retardant paints that the approved by the Central Building Research Institute (C.B.R.I.), Roorkee. As the fire retardant paint is likely to be costly, the schools are hereby allowed 3 years time to get this job completed. However, while purchasing new furniture for the schools the management shall ensure that the new furniture is either painted with fire retardant paint or fabricated out of fire resistant materials.

In view of above, position it may not be appropriate to get the office furniture painted with fire retardant paint to be procured for Shaheed Bhagat Singh Place, New Delhi.

The case was submitted by the Chief Engineer before the Chairman as per note below:-

4. Detailed proposal on the subject/project:

"The agenda for the above work was placed before the Council vide item No. 33 (A-100) dated 30.09.09. The item was regarding procurement of furniture/office equipments to be supplied by M/s. Godrej for remodelling of office space for commercial department to be shifted to Shahed Bhagat Singh Place. During deliberation it was desired by the Council that all office equipments and furniture to be supplied will be fire retardant. It was also desired that Fire Officer of NDMC will counter check and verify all the material supplied that the material is fire retardant.

Now FO-Cum-NA has brought out that the fire retardant material is required only in the case of schools as per instructions issued by Principal Secretary (Home) dated 20.1.05 which says that all the furniture of school should be fire retardant. Besides this, it is to be intimated that M/s. Godrej has already intimated that the additional expenditure to the tune of 30 to 35% will be required to be incurred for making the furniture fire retardant. However this may not be totally possible since office furniture do have leather and cotton upholstery.

Under these circumstances the Resolution No. 33 (A-100) is required to be modified to the extent that the fire retardant furniture will only be obtained for the schools."

5. Financial implications of the proposed project/subject:

Since the use of Fire retardant material has not been made mandatory by the Dir. (Education), Govt. of NCT, and since the use of fire retardant material may not be totally possible for office furniture, thus savings to the extent of 30-35% of the cost can be achieved.

3. Brief History:

A Sub-Committee was constituted for up-gradation of various NDMC Housing Complexes and based on the report of Sub-Committee case for 'Improvement and upgradation of Gandhi Sadan Housing Complex' flats, Mandir Marg was initiated. The said Housing Complex' has 96 Nos. 4-storeyed Type-II flats. No major work of improvement has been taken up in the Housing Complex in recent past and therefore during inspection of the complex by the Sub-Committee it was recommended to take up the proposal of upgradation as these are essentially required. Accordingly, an A/A & E/S of Rs. 1,39,41,300/- (Rupees one crore thirty nine lakh forty one thousand three hundred only) was accorded by the Council vide Resol. No. 05(A58) dated 22.07.2009. Based on approved Detailed Estimate was prepared and draft NIT was approved by the Competent Authority for call of tender.

4. Detailed proposal on the subject/project:

After completing the codal formalities, item rate tenders were invited as per e-procurement procedure. Total 4 tenders were received and found eligible M/s R. K. Jain & Co. with their quoted rate of 2.71% above the Estimated Cost was lowest. The details of the tenders are as under:-

From the details of the tender it may seen that M/s R.K. Jain & Co. is the lowest tenderer who has quoted the tendered amount of Rs. 1,49,06,909/- which is 2.71% above the said estimated cost. The justification on the prevailing market rates has been checked by Planning Div. which works out to 18.05% above the Estimated cost. From the position explained above, it is clear that justification checked by the Planning Division,

i.e. 18.05% above the estimated cost is much higher than the lowest rate of M/s R. K. Jain & Co. (L-1) who has quoted his rates @ 2.71% above said estimated cost and the percentage of tender cost over justified cost of tender works out as 12.99% below. Therefore, the offer of L-1 is considered reasonable for acceptance by the Competent Authority.

5. Financial implications of the proposed project/subject:

The total financial implication of work is Rs.1,49,06,909 + 3% contingencies. There is Budget Provision of Rs.35 lacs exist under the Head of Account D.4.12.1 for the year 2009-10, however the additional funds have also been sought in the R.E. 2009-2010. & BE 2010-2011.

ITEM NO. 17 (A-134)**1. Name of the Project:**

Name of work: Improvement to Vidyut Bhawan Office Complex (Old Building)

SH: Renovation/Upgradation of Vidyut Bhawan Office Complex (old building)

2. Name of the Department : Civil Engineering Deptt. Zone –II**3. Brief History of the Project:**

Vidyut Bhawan (Old building), of NDMC is a big office complex and was constructed way back in 1970 and till then no major improvement work has been taken up. Accordingly an inspection was carried out on dated 26.9.2008 by Director G.A. along with S.O. to Chairman in the presence of ACE-II (Elect.), Dy. CA-II, EE(BM-II) Elect. And E.E.(BM-III) when it was observed that the office space is not being used properly rather being wasted due to improper designing of sitting arrangement, keeping in view the 13 E.Es are to be accommodated alongwith their technical and ministerial staff there. Presently 9 EEs alongwith their technical and ministerial staff are accommodated in the old building complex and adjoining barracks.

Accordingly a Preliminary Estimate to implement the above scheme was processed and A/A & E/S by the Council was accorded vide Reso. No. 25 (A-28) dated 20.5.2009 amounting to Rs.1,72,65,400/-. This Administrative approval was only for civil work and only 20% of the building cost was considered for electrical work. After the Administrative approval was received certain changes in the scope of work were considered with the approval of the competent authority by taking HVAC system alongwith fire fighting and fire prevention measures and the tender was changed to Composite tender which includes Civil, Electrical and Fire fighting works. Approval was also taken from the competent authority for seeking the revised A/A & E/S after the composite tender is decided for the exact project cost. Accordingly composite tender with revised scope of work was framed amounting to Rs.3,72,51,194/- and got checked from the Planning Division.

Item Rate Composite tenders were invited after completing all the codal formalities and in response Three tenders was received in the **1st call of tenders** which was opened on 20.07.2009 and the rates quoted by the L-1 contractor was found to be very high in terms of the estimated cost being 53.12% higher. Accordingly the tender was rejected and called for the 2nd time. In 2nd call no tender was received. Before 3rd call of tender certain modification in the N.I.T. was made with the approval of the competent authority in respect of the eligibility criteria keeping in view the outcome of the previous 2 calls of tenders.

Accordingly the tenders were called for the 3rd time and opened on 16.11.2009. In all four tenders were received. Out of these four only two have qualified in the technical bid as per the recommendations of the Sub Committee placed in the file. Financial bids were opened on 25.11.2009 in respect of the two qualified firms and the details are as under:

From the above it may be seen that M/s Airwaves Engineering Pvt. Ltd. has quoted an amount of Rs. 5,05,70,708/- which is 35.76% (approx.) above the estimated cost put to tender. The justification has been worked out by Planning Division at 21.16% above the estimated cost of Rs. 3,72,51,194/- put to tender. The quoted rates works out to 12.05% above the justified rates. The quoted rate of the contractor M/s. Airwaves Engineering Pvt. Ltd. was on the higher side as compared to the justified rates and restricting the department to conduct negotiation as per CPWD Manual. As this was the 3rd call of tender and keeping in view the different nature of tender i.e. composite tender comprising of Civil, Electrical & Fire fighting works and time lost in call of tenders for three times, if rejected and re-called, it will amount to further time loss and involvement of extra cost of publication etc. and possibility of increase in market rates also. Further S.E.(P) has also recommended for negotiations. Considering all these facts of this special case, it was recommended for negotiation with the L-1 contractor to explore the possibility to reduce the rates near to the justified rates. As such approval in this regard has been obtained from the competent authority to explore the possibility of getting the rates reduced to the maximum extent. Accordingly negotiations were held with the contractor in the chamber of Chief Engineer in the presence of all the Sub Committee Members viz. S.E(P), S.E. (R), S.E(BM), Sr. A.O.(W), and E.E.BM-III. After great persuasion the contractor agreed to reduce his quoted rates by giving a rebate of 6.4% on the tendered amount and which has been considered quite reasonable because of the nature of work/site constraints. Since negotiated tender cost over the justified cost comes to 4.87% i.e. below 5% permissible as per CPWD Manual, as such it is recommended to accept the tender of M/s Airwaves Engineering Pvt. Ltd. with a revised offer of Rs.4,73,34,183/- which is 27.06% (approx.)above the estimated cost. The negotiated tendered amount is 4.87% over the justified amount of the tender which is also within the permissible limit i.e. 5% as per guide lines laid down in the CPWD works manual at Para 19.4.3.2. The letter of voluntarily rebate given by the contractor dated 10.12.2009 shall form part of the agreement.

4. DETAILED PROPOSAL OF THE PROJECT:

It was observed by the higher authorities as mentioned above that the office space is not being used properly rather being wasted due to improper designing of sitting arrangement, keeping in view the 13 E.Es are to be accommodated alongwith their technical and ministerial staff there. Presently only 09 EEs are functioning from old building. The improvement work will over all result in better efficiency of the staff using modern day gazettes for performing official duties & optimum use of the space availability in the building.

Accordingly Estimate, amounting to Rs. 3,72,51,194/- for composite work has been prepared by taking following improvements as per Architectural drawings issued by C.A. Deptt.:-

- Dismantling of brick walls, RCC slabs/ beam including allied fixtures as per requirement of site/ CA drawings.
- 124mm. & 66mm. thick wooden partitions made of double skin silicate board with GI channel studs etc. inside the boards.
- Dog-legged type staircase leading up to terrace level.
- 18mm. thick granite stone flooring and dado in toilets.
- Vitrified anti-skid tile flooring.
- On exterior wall, Dholpur stone cladding upto ground floor and textured paint for first & second floor.
- Powder coated aluminium glazed doors , windows & clerestory windows.
- Regradation of existing mud phaska has also been considered as per modern technique.
- HVAC System.
- Electrical work.
- Fire Fighting and Fire Prevention work.

5. FINANCIAL IMPLICATIONS OF THE PROPOSED PROJECT.

The Budget provision of Rs. 10.00 lacs under non-plan funds is available vide item No. 414 against head of A/C H.1.8. However Rs. 40 lacs have been sought in RE 2009-2010 and 400 lacs in BE 2010-2011.

7. COMMENTS OF THE FINANCE DEPARTMENT ON THE SUBJECT
