


1. The contractor shall get himself registered as per section – 7 of the building and other construction workers (Regulation of Employment and Conditions of Service) Act, 1996 and all the workers employed on the work shall be registered as beneficiary as per section – 12 of the said act before release of payment.
2. The contractor shall properly maintain Register of Beneficiaries, Health Register, Register of wages / muster roll and report of accident as per various forms under the Delhi Building and other construction workers (Regulation of Employment and conditions of service) Rules, 2002.
3. In all the precast units to be used in the work i.e C.C Interlocking Pavers, Kerb stones & Slabs etc. , Pozzolana Portland Cement (PPC) conforming to IS:1489 (part - I) shall be used.
4. *The contractors should have valid labour license under Sec-12(1) of the contract labour (regulation and abolition) Act 1970*
5. *Contractors shall have to provide the P.F. Nos. and ESI Account Nos. of Casual/ Contract workers. Up-to-date proof of payment through ECS or NEFT to the labour employed at the said work must be produced before preparing passing and dispersing each bill of work.*
6. ~~*All building rubbish and dismantled unserviceable material shall be disposed off at recycling plant of MCD for construction and demolition work at Burari Delhi. Proof of disposal of malba at said plant shall be produced before preparing each bill.*~~
7. *Contractor will deploy at least Labours (skilled or unskilled) on work as per DAR-2018 Vol-I & II as amended from time to time & accordingly make payment of E.P.F. & E.S.I & claim for reimbursement for the same from Engineer-in-Charge.*
8. *Engineer-in-Charge may be ensured that the lowest bidder furnishes either copy of registration or proof of applying for obtaining registration with EPFO and ESIC contractor for such tender called for out sourced services. No payment shall be made to contractor/ agency till copy of registration with EPFO and ESIC is submitted by the contractors from the date of issue of letter of acceptance.*
9. *Junior Engineer-in-Charge of work shall certify and establish that all labours deployed in work have been paid tall wages through ECS/NEFT/ ON LINE/ by payee cheque by the agency/ contractor.*
10. *All dismantled M.S. items shall be taken away by the contractor for which recovery @ Rs. 25/Kg shall be made from contractors bill.*

SPECIAL CONDITION OF NGT:

1. The Contractor shall no store/dump construction material or debris on metalled road.
2. The contractor shall get prior approval from Engineer-in-Charge for the area where the construction material or debris can be stored beyond the metalled road. This area shall not cause any obstruction to the free flow of traffic/inconvenience to the pedestrians. It should be ensured by the contractor that no accidents occur on account of such permissible storage.
3. The contractor shall take appropriate protection measures like raising wind breakers of appropriate height on all sides of the plot / area using CGI sheets or plastic and / or other similar material to ensure that no construction material dust fly outside the plot area.
4. The contractor shall ensure that all the trucks or vehicles of any kind which are used for construction purposes/or are carrying construction material like cement, sand and other allied material are fully covered. The contractor shall take every necessary precautions that the vehicles are properly cleaned and dust free to ensure that enroute their destination, the dust, sand or any other particles are not released in air/contaminate air.
5. The contractor shall provide mask to every worker working on the construction site and involved in loading, unloading and carriage of construction material and construction debris to prevent inhalation of dust particles.
6. The Contractor shall provide all medical help, investigation and treatment to the workers involved in the construction of building and carry of construction material and debris relating to dust emission.
7. The contractor shall ensure that C & D waste is transported to the C & D waste site only and due record shall be maintained by the contractor.
8. The Contractor shall compulsory use of wet jet in grinding and stone cutting.
9. The contractor shall comply all the preventive and protective environmental steps as stated in the MoEF guidelines, 2010.
10. The contractor shall carry out on-Road-Inspection for black smoke generating machinery. The Contractor shall use cleaner fuel.
11. The Contractor shall ensure that all DG sets comply emission norms notified by MoEF.
12. The Contractor shall use vehicles having pollution under control certificate. The emissions can be reduced by a large extent by reducing the speed of a vehicle to 20 kmph. Speed bumps shall be used to ensure speed reduction. In cases where speed reduction cannot effectively reduce fugitive dust, the contractor shall divert traffic to nearby paved areas.
13. The Contractor shall ensure that the construction material is covered by tarpaulin. The contractor shall take all other precaution to ensure that no dust particles are permitted to pollute air quality as a result of such storage.
14. The paving of the path for plying of vehicles carrying construction material is permanent solution to dust control and suitable for longer duration projects. The NIT approving authority shall carry out cost benefit ratio analysis of the same.

Special Conditions for Hiring of TATA ACE

1. One job will be for one day of eight hours, if more job is required, it will be arranged by the contractor.
2. The contractor should have his own TATA ACE along with registration of his name.
3. The contractor shall obtain the programme for collecting malba, procurement of materials from stores and other day to day maintenance works from the JE (concerned) to the service centre, every day in the morning and same must be obeyed positively.
4. If the contractor fails to provide the TATA ACE along with the driver on the required day, a recovery of penal rate per day shall be recovered for noncompliance/partly compliance of the program beside imposition of other recoveries & disciplinary actions.
5. All T & P and running maintenance of cost of the TATA ACE shall be arranged/borne by the contractor.
6. The rate quoted by the contractor shall also include the wages of the driver/diesel and mobile oil, etc and nothing extra, whatsoever will be paid in this regard.
7. The contractor shall be responsible for any mishap and he has to take all precautions to avoid any accidents. Any challan by the challenging authority shall be borne by the contractor.
