## OFFICE ORDER

New Delhi Municipal Council is going to charge user fee for collection, transportation and disposal of solid waste from generators of waste.

In pursuant to notification of Municipal Solid Waste Management Rules, 2016 by the Central Government in the Gaziette of India vide SO No. 1357 dated 8th April 2016, New Delhi Municipal Council (NDMC) approved levying of user charges vide Resolution No. 33(E-12) dated 25.07.2016, Accordingly, public was notified through newspapers on dated 18.08.2016 regarding application of user charges in NDMC area. Accordingly, New Delhi Municipal Council has resolved to adopt the said Rules for implementation in the area under its jurisdiction with immediate effect i.e. w.e.f. 01.09.2016. Rule 15(f) of the said Rules enjoins the Council to prescribe from time to time user fee as deemed appropriate and collect the fee from waste generators on its own of through authorized agency.

It is brought to the notice of general public that monthly user fee for management of municipal solid waste interalia including door to door collection of municipal solid wastes would be collected by the New Delhi Municipal Council directly from the waste generators through, water bills / property tax bills / bills raised by Estate department for licensed/leased properties or direct collection as per feasibility.

The monthly user fee prescribed for residential, commercial, institutional and other areas of the Council is as under:-
