REGISTRATION OF PHARMACEUTICAL MANUFACTURING FIRMS FOR THREE YEARS.

N.D.M.C. proposes to register Reputed Pharmaceutical Manufacturing firms willing to supply Allopathic Medicines / Drugs to the Council. The conditions for eligibility of registration of firms are:-

The firms should have

- (i) Their own manufacturing facilities. Tolling of all type is forbidden.
- (ii) The Annual turnover sale of the allopathic medicines should be Rs.50 crores or more during the last 3 years along with authentic/certified proof of turnover of allopathic medicines. Annual allopathic medicines turnover will only be considered.
- (iii) Possess a valid GMP certificate as per schedule M of the Drugs and Cosmetics Act and should also have a WHO and ISO 9001 & 9002 certificate.
- (iv) Be having no pending income tax liability. Income tax clearance certificate from the authorized agency is mandatory. Copy of TAN & PAN certificate.
- (v) Experience of supply of medicines to the government hospital/institutions for proceeding 03 years.
- (vi) Adequate facilities for in-house quality control.
- (vii) No conviction or pending conviction certificate
- (viii) Certificate/undertaking regarding the firms that the firm has not been blacklisted by any organization anywhere in the country.
- (ix) Be in the manufacturing business of allopathic medicines for the last 10 years.
- (x) Valid certificate / registration from Drug Controller of India.

The application should be accompanied by registration fee of Rs.10000/- in the form of DD/Pay order in favour of Secretary, NDMC drawn on any

anen

scheduled bank in Delhi/New Delhi. The registration fee is non refundable. Application without registration fee will not be considered.

Manner of Submission of Applications for Registration:

Two Cover systems will be adopted for submission of application.

a. One cover should contain the DD/pay order for registration fee and superscribed as "Registration Fee" on the left upper corner of the envelope.

b. Second cover should contain application for registration along with documents (attested copies) and superscribed as "Application for

Registration and documents."
