## CIRCULAR

NDMC on the analogy of Govt. Fund Deptt wants is getting developed software for proper accounting of NPS subscription (both employee and employer contribution) as per the information available on the data base of Pay Roll System of NDMC plus interest accrued thereon. All the employee who are covered under the NEW PENSION SCHEME are required to furnish the S-I form which is available in NDMC website i.e. www.ndmc.gov.in

All the HODs are requested to kindly issue the instructions to their staff to fill the S-I form from all the employees who are covered under NPS Scheme and forward to Fund Branch before 15<sup>th</sup> Jan, 2015.
