MINUTES OF MEETING OF STATE LEVEL HIGH POWERED STEETING COMMITTEE (HPSC) HELD ON 12/05/2016 AT 3.00 PM IN THE OFFICE OF CHIEF SECRETARY, DELHI, 5TH LEVEL 'A' WING, DELHI SECRETARIAT, I.P. ESTATE, NEW DELHI 110113, to REVIEW THE PROPOSED REVISION IN SMART CITY PROPOSAL OF NEW DELHI MUNICIPAL COUNCIL (NDMC). NEW DELHI.

- 1. The State Level High Powered Steering Committee (HPSC) held the meeting at 3.00 P.M. on 12/06/2016 under the chairmanship of Chief Secretary, Govt. of N.C.T. of Delhi, to examine and approve the revised Smart City Proposal (SCP) of N.D.M.C. which has been prepared by NDMC on the basis of observations of panel of experts of Ministry of Urban Development, Government of India.
- 2. NDMC informed the Committee that subsequent to the approval of the Smart City Proposal of NDMC by HPSC in its last meeting held on 11/12/2016, the proposal was submitted to Ministry of Urban Development, Government of India on 15/12/2016 for Stage-2 of Round-1 of Smart City competition. NDMC has been selected as one of the first 20 cities by the MoUD under City Challenge Round 1 of the Smart City Mission of the GOI on 28/01/2016.
- 3. It was also informed that while conveying the decision, MoUD has informed vide D.O. letter No. K-15016/209/2015-SC-I Dated 09/02/2016 that while assessing the Smart City proposals, the panel of experts has made some observations about how improvements can be made in Smart City Proposal. The observations of the panel of experts in SCP of NDMC have been conveyed on 11 different aspects of SCP. Further the creation of Special Purpose Vehicle (SPV) has been included in the revision as SPV is going to be integral part of Smart City Proposal. It was informed that as per MoUD guidelines, the first installment of Central share under the Smart Cities Mission will be released by the MoUD on submission of the revised SCP and the establishment of (SPV) a Public Limited Company.
- 4. It was informed that the primary reason for creation of an SPV for Smart City Mission is to ensure operational independence and autonomy in decision making and mission implementation.
- Chairman, NDMC further informed that the revised SCP and proposal to establish SPV has been approved by Council in its meeting held on 26/04/2016. Minutes of the meeting will be confirmed in the next meeting of the Council.
- 5. The Chairman, NDMC briefly outlined the proposed changes in the Smart City Plan of NDMC as well as the salient features of SPV which is proposed to be

established, including the Article of Association and Memorandum of Association and overall structure and function of SPV. The briefing inter alia included extensive detailing in "happiness areas", action plan on involving property owners as per Area Based Development (ABD) requirements for its various projects, improvement on hawkers policy, provisioning sensor based multi utility duct for developing CGD network.

6. After due deliberations on each aspect of the revised SCP and proposal for establishment of SPV, HPSC agreed to the proposed amendment/improvements and creation of SPV and its submission to Ministry of Urban Development, Government of India, alongwith Minutes of Meeting of Council in respect of agenda for the revision of SCP and creation of SPV.

The meeting ended with vote of thanks to the Chair.
