New Delhi Municipal Council proposes to fill up one (01) post of Joint Director (Vigilance) in pre-revised 6th CPC Pay Scale of PB-3 Rs.15600-39100 + Grade Pay Rs.6600/- (revised to Level 11 in 7th CPC), on deputation basis. The eligibility criteria required for the post is as under:-

Officers under the Central/State Govts./UTs :-

- (a) (i) Holding analogous posts on regular basis; or
 - (ii) With five years regular service in post in the pre-revised scale of Rs.15600-39100 + Grade Pay Rs.5400/- or equivalent; or
 - (iii) With six years regular service in posts in the pre-revised scale of Rs.9300-34800 + Grade Pay Rs.4800/- or equivalent on administrative/technical side; and
- (b) Possessing the following educational qualifications and experience:
 - (i) Degree from a recognized university or equivalent.
 - (ii) Atleast two years experience as :
 - a) DVO (Departmental Vigilance Officer) or
 - b) Asstt. to DVO or having worked in Vigilance Deptt. with knowledge of processing of cases with CVC, CBI etc.
- The departmental officers in feeder category who are in the direct line of promotion shall not be eligible for consideration for appointment on deputation.
 Similarly, deputationists shall not be eligible for consideration for appointment by promotion.
- 3. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/deptt. of the Central Govt. shall ordinarily not exceed five years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.
