VACANCY CIRCULAR-CORRIGENDUM

To,

Subject : Filling up the post of Director in NDMC on deputation basis in PB-3 ₹15600-39100 with Grade Pay of ₹7600/- (pre-revised).

Reference: NDMC's letter no. SO(E)/1959/SA-I(R) dated 17/11/2016

Sir,

In continuation of this office letter no. SO(E)/1959/SA-I(R) dated 17/11/2016 and subsequent corrigendum dated 25.11.2016, it is informed that the post of Director in NDMC is operated in two pay scales viz. ₹ 15,600-39,100 Grade Pay ₹ 7,600/- or ₹ 37,400-67,000 Grade Pay ₹ 8,700/-, whichever is applicable.

2. Accordingly, the pay scales of Director level officers in NDMC appointed on deputation basis shall be governed as per following:
 - i. Officers working at Director level but drawing pay in PB-3 with grade Pay less than ₹ 7600/- (Pre-revised) in parent cadre, will draw salary in PB-3 with Grade Pay of ₹ 7600/- (Pre-revised) with no deputation allowance.
 - ii. Officers working at Director level but drawing pay in PB-3 with Grade Pay ₹ 7600/- (Pre-revised) in parent cadre but less than five year service in the grade of ₹ 7600/- (Pre-revised) will draw salary in PB-3 with Grade Pay of ₹ 7600/- (Pre-revised) alongwith deputation allowance.
 - iii. Officers working at Director level but drawing pay in PB-3 with Grade Pay ₹7600/- (Pre-revised) in parent cadre for five years or more than five, will draw salary in PB-4 with Grade Pay of ₹ 8700/- (Pre-revised) with no deputation allowance.
 - iv. Officers working at Director Level but drawing pay in PB-4 with Grade Pay ₹8700/- (Pre-revised) in parent cadre will draw salary in PB-4 with Grade Pay of ₹ 8700/- (Pre-revised) with deputation allowance.
3. Vacancy circular corrigendum issued vide No. SO(E)/2043/SA-I(R) dated 25.11.2016 is withdrawn.
4. The eligibility condition for the post stand modified as indicated above. The remaining terms and concitions and last date of receipt of application i.e. 16.12.2016 remain unchanged.
