2. **Essential Qualifications & Criteria for Junior Resident: -**

- i) M.B.B.S Degree from a recognized university or equivalent qualification recognized by MCI and registered with Delhi Medical Council (DMC).
- ii) Candidates must have completed their internship on or before 01.03.2019.
- iii) DMC Registration is mandatory at the time of joining.
- iv) Those who have already done one year Junior Residency in any Govt. Hospital Shall not be considered and need not apply.

3. **Age as on 01.03.2019:** Not more than 30 years, the age is relaxable for SC/ST/OBC/PH as per rules (GOI).
