The Committee also noted as under:-

- The Estate Department did not represent and hence the Empowered Committee decided that cases for renewal which were deferred earlier now stands approved assuming that Estate Department have no any objection for renewal of the same, my not issue health license or curs when the license period to find. (i)
- The Committee was informed that several units are operating as General Store and other commercial trade activities in B.K.Dutt Colony where commercial activities are not permitted as per (ii) the views of the Architect Department. Accordingly, it was agreed that stoppage notice of trade activities may be issued to all such units.
- As regards Kiosks (Sl.No.29 to 33), the clarification from the Estate Department with respect to the usage permission in terms of lease deed for selling fruit juice, tea coffee etc. which (iii) creates insanitary conditions on account of non-availability of water connection, drainage etc. may be sought and till then the renewal of licenses for such kiosks may be deferred.

Further, as the Health Licenses are contingent upon meeting the required Building Bye Laws, Provisions of Lease deed Agreement, payment of outstanding municipal dues etc. on time, any (iv) violations noted by respective departments in case of approved cases may be brought to the notice of Health Department for revoking of health licence
