Director(Estate-I) informed the Committee that licence deed in respect of many properties are pending for renewal and renewal is yet to be completed as it requires confirmation of the minutes and technically no licence can be renewed in this regard. However, Director(Health Licensing) informed that Health Licensing Department do not (i) have any option but to close the restaurants without a proper Health License and hence such renewals of licence deed need to be expedited or there will be chaotic situation in the markets. Keeping in view the public interest and administrative expediency, through consensus it was decided that health licence with respect to Estate-I properties may be renewed only for three months. Further decision would be taken after the completion of three months. So a letter for three months instead of license be issued. Licence fees may be recovered later on while issuing licence.

Director (Estate-II) clarified that there are certain pending dues, violations and encroachment of public land by some properties pertaining to the Estate-II and hence an Affidavit (ii) in this regard may be obtained from such cases before renewals and copy of the affidavit may be endorsed to the Estate-II and Enforcement Department for remedial action, if

required.

Director (Tax) reported that on account of litigations with respect to Determination of Annual Rent Bye Laws (Unit Area Method) before the Hon'ble Supreme Court for (iii) adjudication, till the decision comes recovery cannot be enforced. In view of this, there is no objection from the Property Tax Department. However, all the licenses/tax payers are supposed to clear the outstanding dues when the bills are issued to them. An undertaking may also be obtained from the respective licenses/tax payers in this regard.

Director (EBR) and Director (Enforcement) were advised to keep a close watch on each and every property where the health licenses are being issued so that if any kind of (iv)

violations is detected same may be informed to Department for cancelling the license.
