## Minutes of the First Meeting of the Town Vending Committee(TVC) dated 17.06.2016

The first meeting of the Town Vending Committee(TVC) constituted by the GNCT of Delhi under the provisions of Rule 12 and 13 of the Delhi Street Vendors(Protection of livelihood and Regulation of Street Vending) Rules 2016 in respect of New Delhi Municipal Council, was convened under the chairmanship of Chairman, NDMC on 17.6.2016 at 4.30 PM in Council Room, Palika Kendra, NDMC. The meeting was attended by the following members of the TVC:

The following was deliberated:

- (i) All members of the TVC were provided the copies of Street Vendors(Protection of Livelihood and Regulation of Street, Vending)

  Act, 2014 alongwith Scheme and Rules.
- (ii) The members introduced themselves and expressed their point of views.

- (iii) Market Traders Associations pointed out that livelihood of shopkeepers of the markets have to be taken into consideration. Unauthorized hawking should be removed. A regulated hawking activity may be ensured by the TVC so as to stop unauthorised vending in front of shops and to maximize the revenue in terms of VAT, Service Tax etc.
- (iv) SDM, Chanakyapuri stated that rights of pedestrians, public pathways, walkways have to be protected for their safety, security and proper pedestrians movement
- (v) Members representing the vendors/tehbazaries holders requested that the existing tehbazari holders and the vendors who are having certificate of vending may be regularized in situ at the same place. This was also echoed by the NGOs.
- (vi) Members representing the RWAs stated that a regulated activity of the hawkers should be put in place and the name of the person, licence number etc. should be prominently displayed to check the unauthorised vendors and violations on their part.
- (vii) Officials of Public Health and Civil Engineering Departments requested the Committee members for maintaining cleanliness and hygiene in the area.
- (viii) Director(Enf.) explained the functioning and responsibilities of the TVC and informed the committee that the Hon'ble High Court vide order dated 18.5.2016 in LPA No. 136/2016 had directed that TVC exercising jurisdiction over NDMC areas should conduct the survey in accordance with the scheme with respect to identification of specific sites/spaces within two months. Director (Enforcement) requested the members to cooperate for completing the task within the stipulated two months period as per the directions of the Hon'ble High Court.
- (ix) All the members of the TVC have requested that one week's prior notice alongwith agenda may be provided before the date of next meeting.



- (x) Director (Enforcement) has also explained that as per the directions of Hon'ble High Court in its order dated 18.05.2016, all the encroachments on the footpath/walk ways have been surveyed, photographs were taken and list was prepared and the same is being uploaded on the NDMC's Website. It was informed that these encroachments on footpath are being removed to ensure that two meter width on the footpath would be left.
- (xi) It was also informed to the TVC members that survey regarding encroachment on the various footpaths in and around Connaught Place and Palika Bazaar will be taken up and the members of the TVC will be informed who can supervise the work of the inspectors while doing such survey for identification of vending sites/spaces and unauthorised encroachments so as to remove those obstructing footpath or walk way, for ensuring compliance of the Hon'ble High Court order dated 18.05.2016.

## Conclusion:

Chairperson, NDMC advised that Enforcement Department may circulate the duties and responsibilities of the TVC and also circulate the agenda for next meeting as per the directions of Hon'ble High Court.
