## **INVITATION FOR EXPRESSION OF INTEREST (EOI)**

## Sub: Upgradation/ Beautification of Central Park, Connaught Place.

1.0 Central Park is located at centre of Connaught place and is one of the most important aspects of Connaught Place. Overall area of Central Park is approx 39000 SQM, out of which 27000 SQM is green area. With possessing one of the largest National Flag in country, the area becomes an important tourist destination. It is important that the park should be developed/ beautified at the World Class Level. The park shall be upgraded with installation of Dancing and musical fountain of International Standard with Laser Show, modern horticulture/Landscaping works and technical aspects in context of security and disaster management incorporating norms in upgradation of park. The NDMC proposes to appoint a services consultant of repute on 80:20 (Technical: Financial) basis who has expertise in design, estimate and supervision of various services of a project of this magnitude. The appointment of two separate Consultants of repute is proposed by NDMC who has expertise in (i) Dancing & musical fountains of international standard with laser show (ii) Landscaping/horticulture works and high tech security with all the disaster management arrangements etc.

#### Part-I

## Consultancy for below mentioned work:

Installation of dancing and musical fountain of International standard with laser show for creating an aesthetic design (including three-dimensional images) by employing effects of timed sound waves and timed lights (including laser) involving programmed computerized control systems.

#### Part-II

# **Consultancy for below mentioned works:**

- I. It is proposed to restrict the entry of general public to the area surrounding the National Flag and the same shall be developed with all season colourful plantations, (one of the finest horticultural / plantation work) to enhance the splendid glory of the National Flag amongst the evergreen development.
- II. Amphitheatre/ Event Space in Central Park areas also require high end plantations and grandeur landscaping attraction. Keeping in view the heavy footfall, the green is to be developed with advanced technology.
- III. The Central Park shall also be equipped with high tech security alongwith all arrangements for Disaster Management to cop up the any eventuality.
- IV. Landscaping of park, use of graffiti and modern art painting, beautifications using sculptures, stones and pebbles etc, music system, and Electronic informatory boards are also included in scope.

EOI is invited from consultants who fulfil the following minimum criteria:

## **Consultant for Part-I**

- a) A reputed Consultant having in house expertise for providing Consultancy for dancing and musical fountain of International standard with laser show.
- b) Successfully provided similar consultancy for at least two completed projects of similar nature costing **two crore** each or more within last seven years out of which at least one project should have been completed within last two financial years.
- c) They shall also provide annual turnover figures and net profit for last three year duly verified from their chartered accountant.

#### **Consultant for Part-II**

- a) A reputed Consultancy having in house expertise in the field of Horticulture, Beautification & Landscaping. However, the selected consultant may outsource firms of repute in the field for disaster management plans ,tech security and other technical aspects mentioned in Part-II, with prior approval of NDMC.
- b) Successfully provided similar consultancy for at least two completed projects of similar nature costing **one crore each** or more within last seven years out of which at least one project should have been completed within three two financial years.
- c) They shall also provide annual turnover figures and net profit for last three year duly verified from their chartered accountant.

Therefore, for the above proposed upgradations / Beautifications of the central park to make it World Class destination with all infusion of advanced Smart High Tech technology, Interested Consultants shall submit Complete profile of their Company including experience of similar nature of work.
