


- (i) Director(Estate-I) clarified that the renewal of licence deed in some of the cases of Estate Property are pending for decision of Council and hence, the cases where licence deed are not renewed, temporary permission for three months may be granted for the operation of the restaurants.
- (ii) Director(Estate-II) clarified that there are issues of unauthorized constructions, misuse, encroachments and Govt. dues in respect of properties of Estate-II Deptt. and their licenses be issued only after getting the undertaking from the applicants and same may be forwarded to the department for further necessary action/advise.
- (iii) Secretary, NDMC advised that the pendency of applications must be liquidated at the earliest and it may be tried that meeting be convened weekly basis till disposal of all such cases. The CMOs are directed to prepare the Agenda Item for the next meeting within three working days and all the applications received as on 15th May, 2018 may be included in the Agenda item.




