Office Order

A need has been felt to review the level of Public Information Officer (PIO) and First Appellate Authority (FAA) in NDMC. It has been noted that in some departments/Divisions, officers of not sufficient higher rank are disposing the applications received under RTI Act, 2005 as PIO. Disposal of such applications at lower level is fraught with the risk of non-compliance with provisions of RTI Act, 2005, Orders issued by the Central Information Commission and Hon'ble Courts from time to time, which further results into avoidable appeals. It has therefore, been decided that the FAA will be Head of the Department (HoD) and the PIO should be the immediate junior officer reporting to the FAA but he should not be below the rank of PB 3: Grade Pay Rs.5400 (Level 10 in 7th CPC). Where there is no officer of this rank under the FAA, any other PIO be entrusted with this job of disposal of RTI applications of that particular branch, who will be assisted by an APIO. The APIO may be any officer/official of that branch/section, to be identified by such PIO.
