Officers under the Central/ State Govts/ Union territories/ University/ recognized research institution/ PSUs/ recognized or autonomous or statutory organizations:

- (a) (i) holding analogous post on regular basis in the parent cadre/department or
- (ii) with three years service in the grade rendered after appointment thereto on a regular basis in posts in pay band -4 of pay scale of Rs. 37400-67000 plus grade pay of Rs. 8700 or equivalent in the parent cadre/ department; OR
- (iii) with eight years service in the grade rendered after appointment thereto on a regular basis in posts in pay band-3 of pay scale of Rs. 15600-39100/- plus grade pay of Rs. 7600 or equivalent in the parent cadre/ department; and
- (b) possessing the following educational qualifications and experience:
- (i) A recognized Medical qualification included in the first or second schedule or part-II of the third schedule (other than licentiate qualification) to the Indian Medical Council Act, 1956;
- (ii) Post Graduate Degree/ Diploma in Social and Preventive Medicine/ Community Medicine or any public health qualification specified in any of the schedule to the Indian Medical Council Act, 1956 from a recognized University/ Institution;
- (iii) Ten years practical and Administrative Experience in the field of public health after obtaining post graduate degree or 15 years experience after obtaining post graduate diploma mentioned at (ii) above.

- 2. Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/deptt. of the Central Govt. shall ordinarily not exceed five years. The maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of receipt of applications.
